I was also well acquainted with the family and near relatives of the Decedent. To the best of my knowledge and belief, the decedent DID NOT have a surviving spouse.


Decedent had the following children:

And Affiant further states that Decedent left no other children (living or deceased) or adopted children (living or deceased), nor descendants of deceased children or deceased adopted children.


Affiant states that his/her relationship to the Decedent was that of

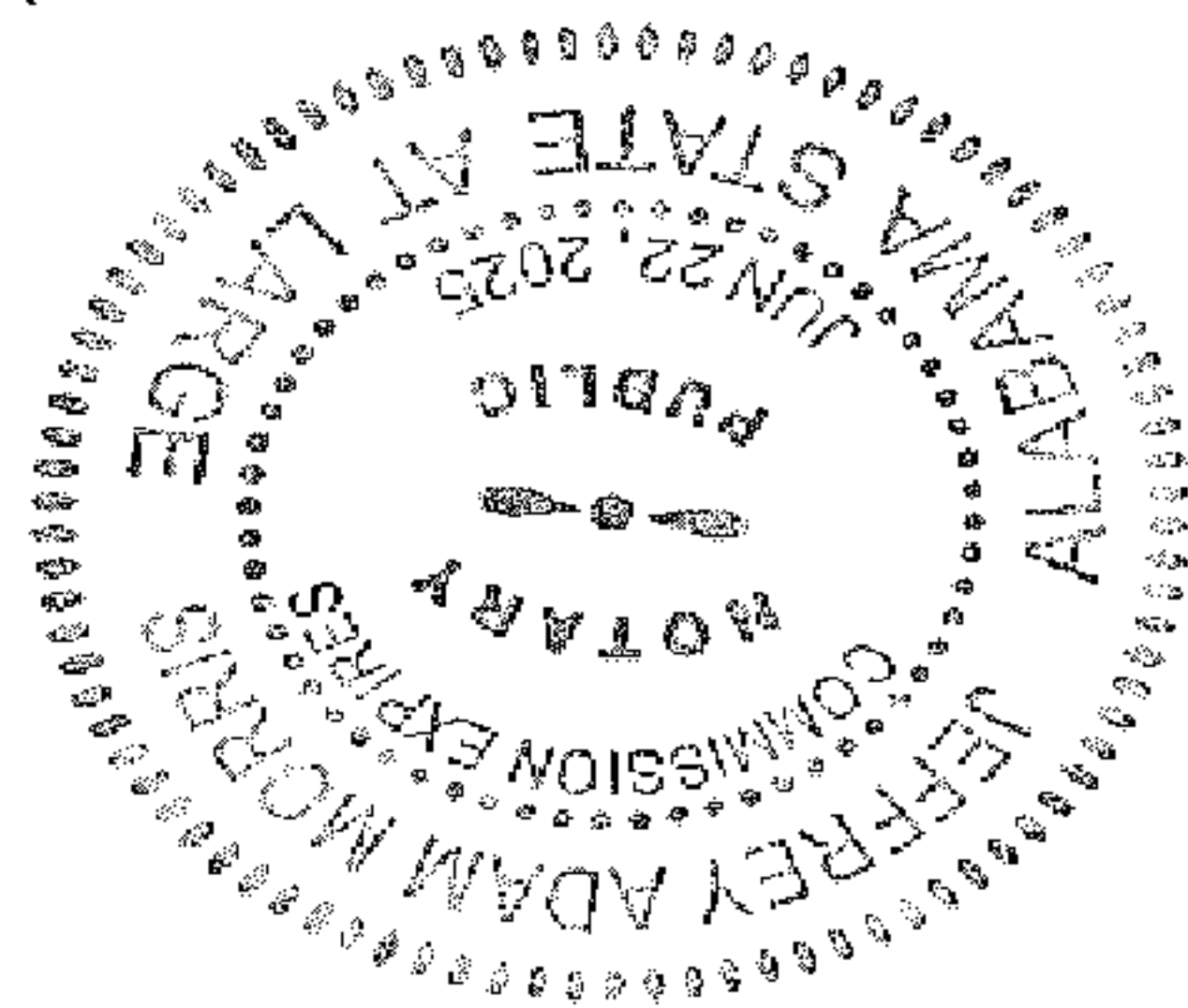
