**GENERAL WARRANTY DEED**  
**With Right of Survivorship**

KNOW ALL MEN BY THESE PRESENTS, that for and in consideration of THREE HUNDRED FORTY EIGHT THOUSAND AND 00/100 (\$348,000.00), and other good and valuable consideration in hand paid to Amber Pope, Personal Representative of Estate of Michael W. Johnson, Shelby County Probate Case No. PR-2022-000003 (hereinafter referred to as "Grantor(s)"), the receipt and sufficiency of which is hereby acknowledged, by the Brent Borden and Courtney Borden, a married couple (hereinafter referred to as "Grantee(s)"), Grantor(s) hereby GRANT(S), BARGAIN(S), SELL(S) and CONVEY(S) unto Grantee(s), for and during their joint lives as joint tenants with rights of survivorship and upon the death of either of them, then to the survivor of them in fee simple, together with every contingent remainder or right of reversion, the following described real estate situated in Shelby County, Alabama, to-wit:

**Lot 21, according to the survey of Eagle Cove Subdivision, as recorded in Map Book 35, Page 121, in the Probate Office of Shelby County, Alabama.**




