KNOW ALL MEN BY THESE PRESENTS, that for and in consideration of the sum of **TWO THOUSAND** dollar(s), cash in hand paid to the undersigned by Shelby County, the receipt of which is hereby acknowledged, I (we), the undersigned grantor(s), **Betty Mitchell** have this day bargained and sold, and by these presents do hereby grant, bargain, sell and convey unto Shelby County the following described property:

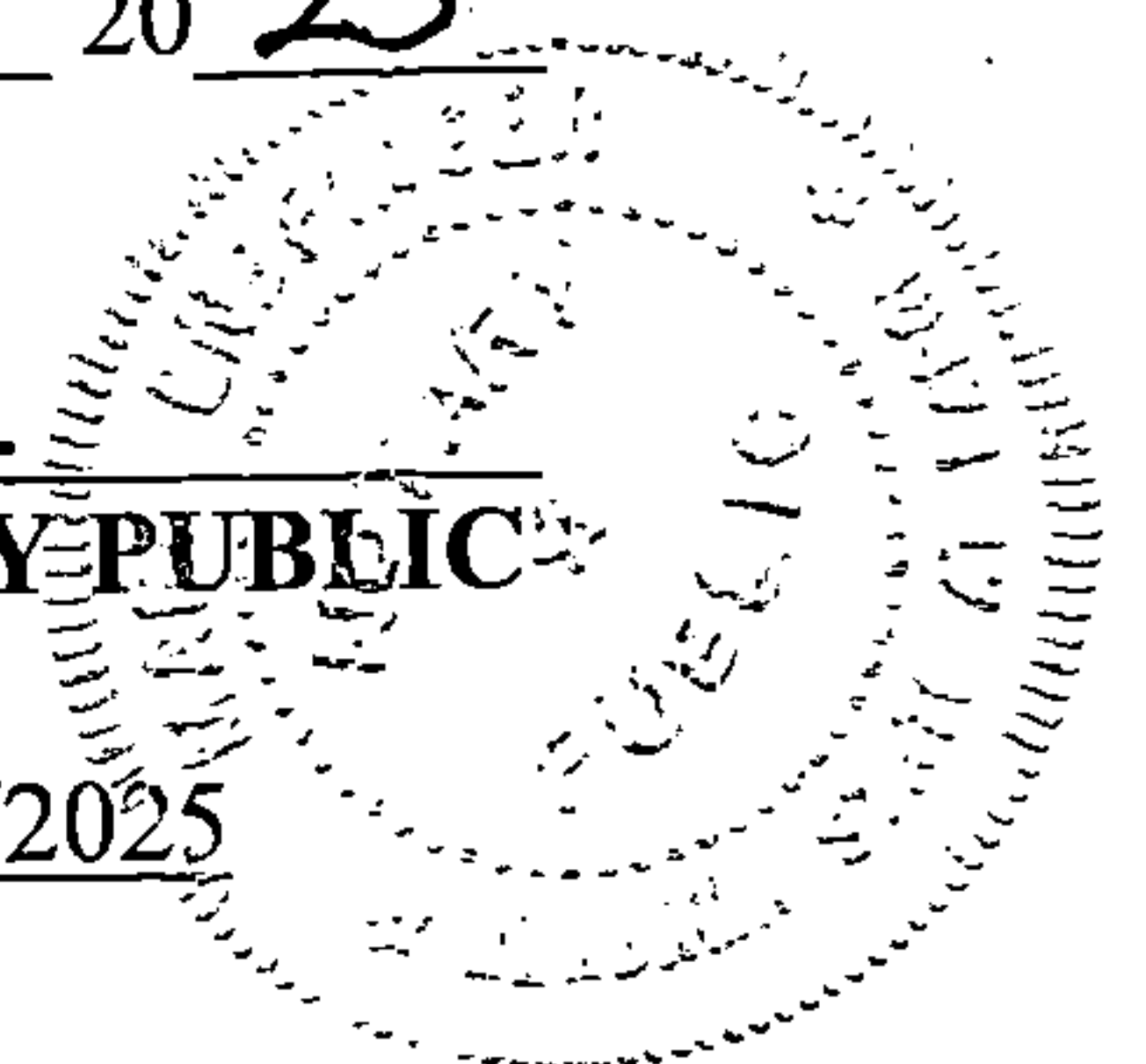

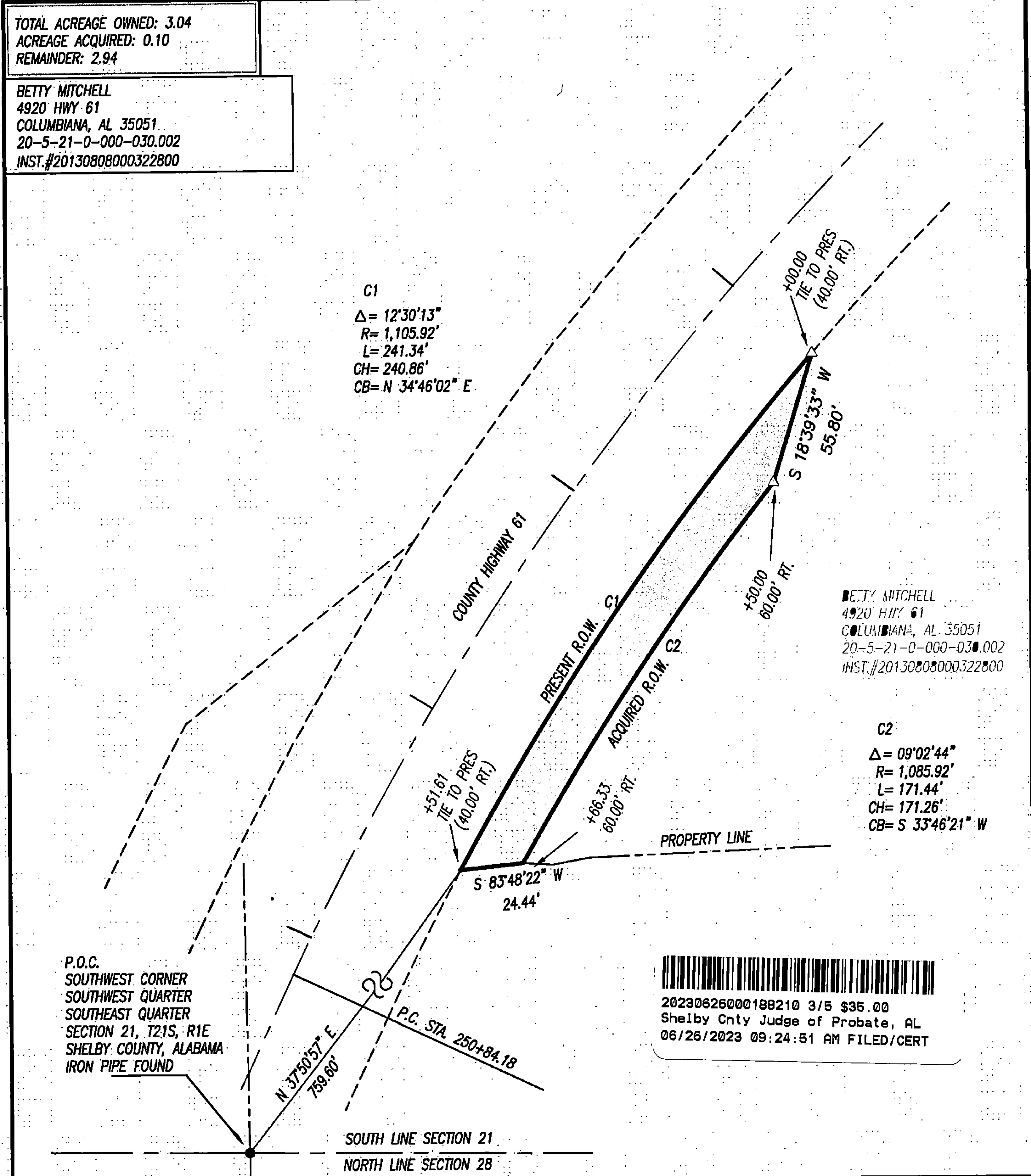

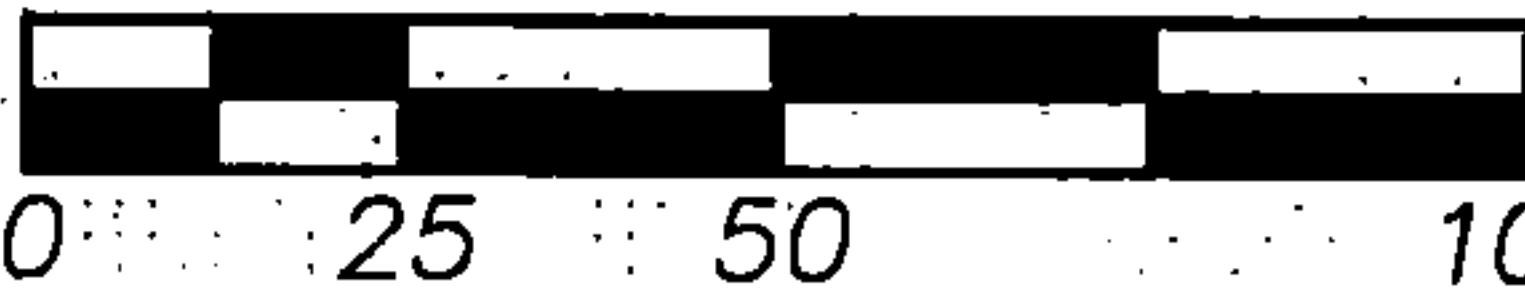
