
**SUBJECT TO ALL MATTERS OF RECORD**

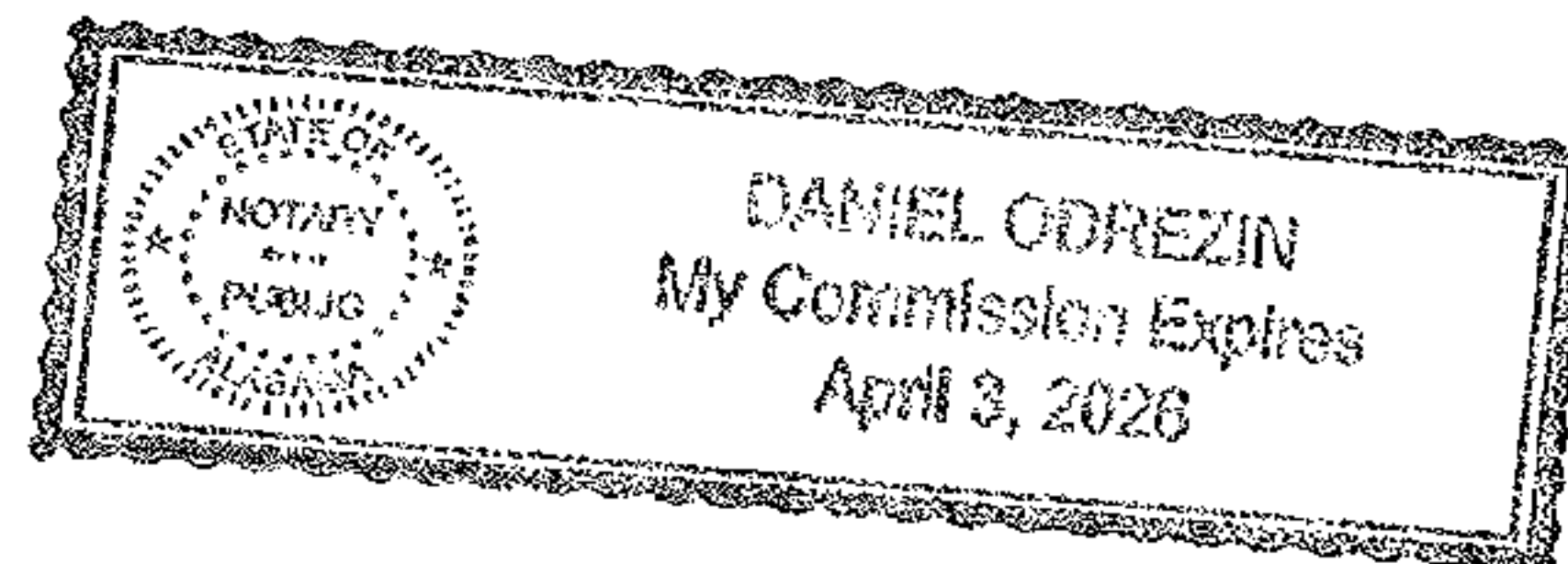
