MORTGAGE FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, That:

WHEREAS, heretofore, on to-wit, June 23, 2000, **Ricky Moore, and Donna Moore, Husband and Wife, Mortgagor**, did execute a certain mortgage to **GMAC Mortgage Corporation DBA ditech.com**, which said mortgage is recorded in Instrument No. 2000-21973, in the Office of the Judge of Probate of Shelby County, Alabama.; and

WHEREAS, said mortgage and the debt thereby secured was last transferred and assigned to **Global Proceeds, LLC**, as transferee, said transfer is recorded in Instrument 20230405000094430, aforesaid records, and Global Proceeds, LLC, is now the holder and owner of said mortgage and debt; and

WHEREAS, on June 20, 2023, the day on which the foreclosure sale was due to be held under the terms of said notice, between the legal hours of sale, said foreclosure was duly and properly conducted and Global Proceeds, LLC did offer for sale and sell at public outcry, in front of the main entrance of the courthouse door of the Shelby County, Alabama Courthouse; and

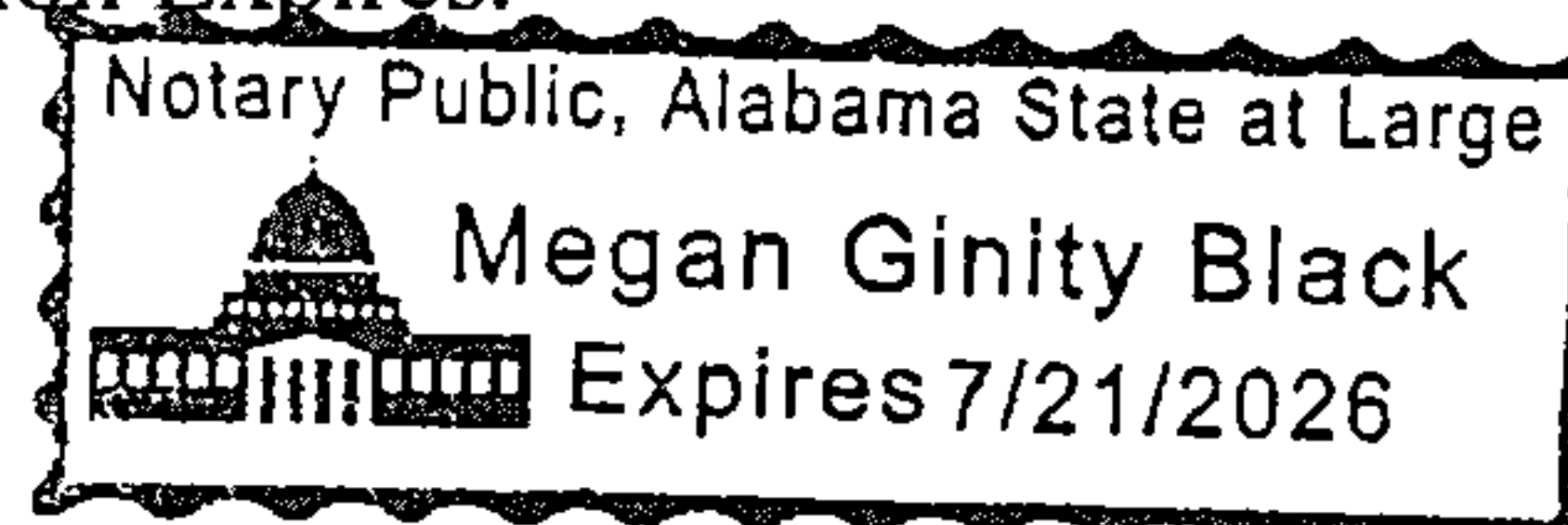

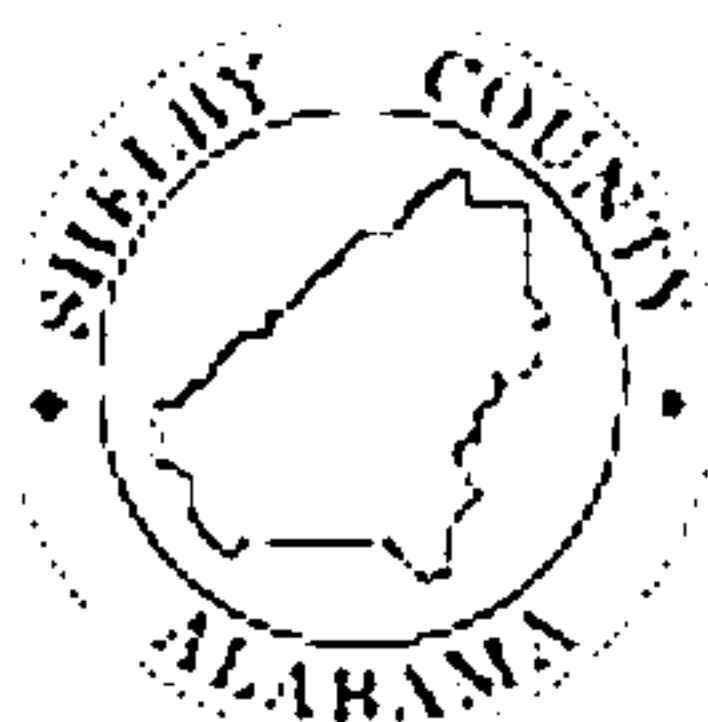
