# **WARRANTY DEED**

Joint With Right Of Survivorship

**KNOW ALL MEN BY THESE PRESENTS,** That in consideration of the sum of Three Hundred Seventy-Five Thousand And No/100 Dollars (\$375,000.00) paid by the grantee herein, the receipt of which is hereby acknowledged, I/we, Daniel Decker and Jessica Decker, a married couple (hereinafter grantor, whether one or more), do grant, bargain, sell and convey unto Tony Tobias and Meredith Tobias (hereinafter Grantees), as joint tenants with rights of survivorship, all of my/our right, title and interest in the following described real estate, situated in Shelby County, Alabama.

Lot 115, according to the Survey of Willow Oaks, as recorded in Map Book 38, Page 137, in the Probate Office of Shelby County, Alabama.

Subject to current taxes, all matters of public record, including, but not limited to easements, restrictions of record, and other matters which may be viewed by observation.


