That in consideration of the sum of **Three Hundred Ninety Thousand Dollars and No Cents (\$390,000.00)**, the amount of which can be verified in the Sales Contract between the parties hereto, to the undersigned Grantor (whether one or more), in hand paid by the Grantee herein, the receipt whereof is acknowledged, I or we, **Charles S Vifquain and Lora B. Vifquain**, husband and wife (herein referred to as Grantor, whether one or more), grant, bargain, sell and convey unto **Johnny Mack Crim and Tammie Tubbs**, as joint tenants with right of survivorship (herein referred to as Grantee, whether one or more), the following described real estate, situated in Shelby, County, Alabama, to wit;

Lot 11, according to the Survey of Indiancreek, Phase 1, as recorded in Map Book 14, Page 45, in the Office of the Judge of Probate of Shelby County, Alabama.

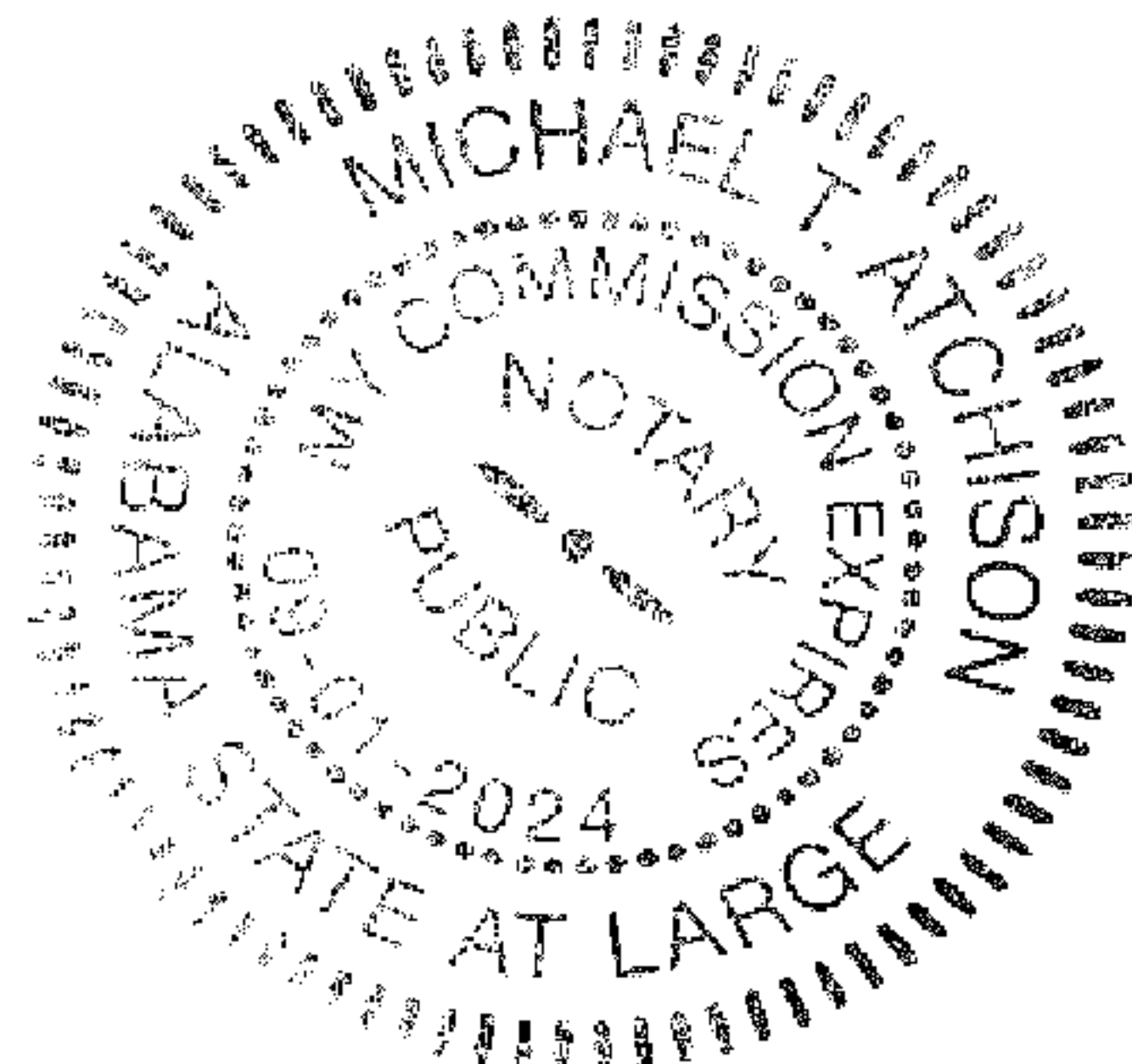
