That in consideration of Two Hundred Eighty-Nine Thousand One Hundred and 00/100 (\$289,100.00) Dollars and other good and valuable consideration paid in hand by the GRANTEE herein to the undersigned GRANTOR, the receipt and sufficiency whereof is acknowledged,

D.R. Horton, Inc. – Birmingham (herein referred to as GRANTOR, whether one or more) does, grant, bargain, sell and convey unto

Suzanna Gibson Slawson (herein referred to as GRANTEE), all of its right, title and interest in and to that certain real estate situated in Shelby County, Alabama, to-wit:
