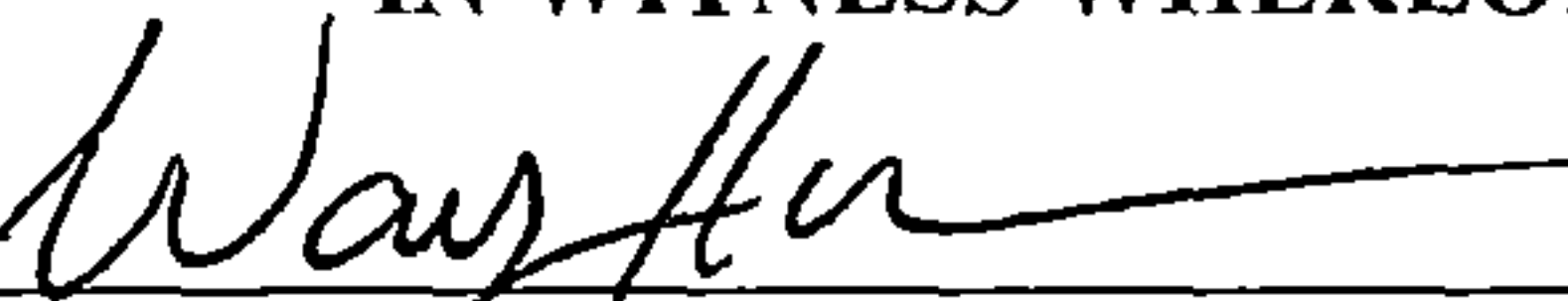
Subject to taxes, restrictions, rights-of-way, exceptions, conditions, covenants and easements of record.

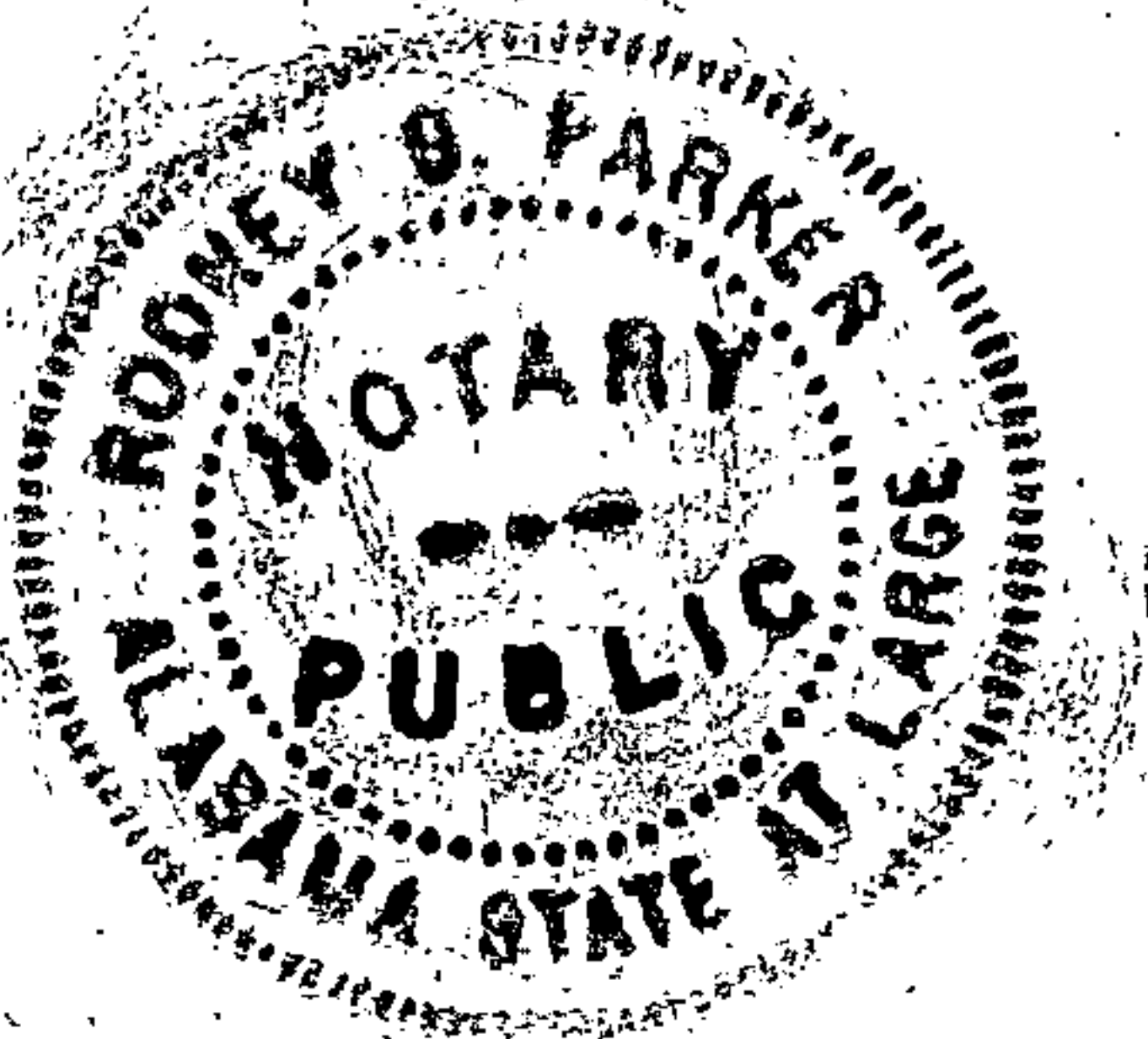
