KNOW ALL MEN BY THESE PRESENTS: That in consideration of **Three Hundred Twenty-Seven Thousand and No/100 Dollars (\$327,000.00)** and other good and valuable consideration, to the undersigned grantor, in hand paid by the grantees herein, the receipt where is acknowledged I, **Cynthia Decker Davis, an unmarried person, and Charles E. Decker, an unmarried man** (herein referred to as grantor), grant, bargain, sell and convey unto **Dorothea G. Colley and Lucious Colley, Jr.** (herein referred to as grantees) for and during their joint lives, and upon death of any of them, then to the survivor(s) of them in fee simple, together with every contingent remainder and right of reversion, the following described real estate situated in **Shelby County, Alabama**, to wit:

Lot 2, according to the Survey of Country View Estates, Phase Three, as recorded in Map Book 51, Page 41, in the Office of the Judge of Probate of Shelby County, Alabama.






