
ORDINANCE NO. 091-05



AN ORDINANCE TO AMEND THE CODE OF ORDINANCES, CITY OF PELHAM, ALABAMA, HERETOFORE ADOPTED BY THE CITY OF PELHAM, ALABAMA TO ADJUST THE WATER FEES SCHEDULE FOR RESIDENTIAL AND COMMERCIAL CUSTOMERS

WHEREAS, the City of Pelham has evaluated the cost associated with the operation, maintenance, and regulations of the water system; and

WHEREAS, the Mayor/Superintendent of the Utility Systems, the Pelham Water Department, and the Pelham City Council find it necessary to adjust the Water Fees Schedule; and

WHEREAS, the City of Pelham has determined that it is in the best interest of the City to amend Chapter 10, Article II, Section 10-22 of the Code of Ordinances, City of Pelham, Alabama:

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF PELHAM, ALABAMA AS FOLLOWS:

SECTION 1. Chapter 10, Article II, Section 10-22 of the Code of Ordinances, City of Pelham, Alabama shall be and hereby is amended by deleting it in its entirety and by substituting the following therefore:

SECTION 10-22. Water Fees Schedule.

Customers of the City of Pelham's water system shall pay a fee as shown, in addition to any deposit fees, impact fees, or any other costs associated with the connection as noted:




