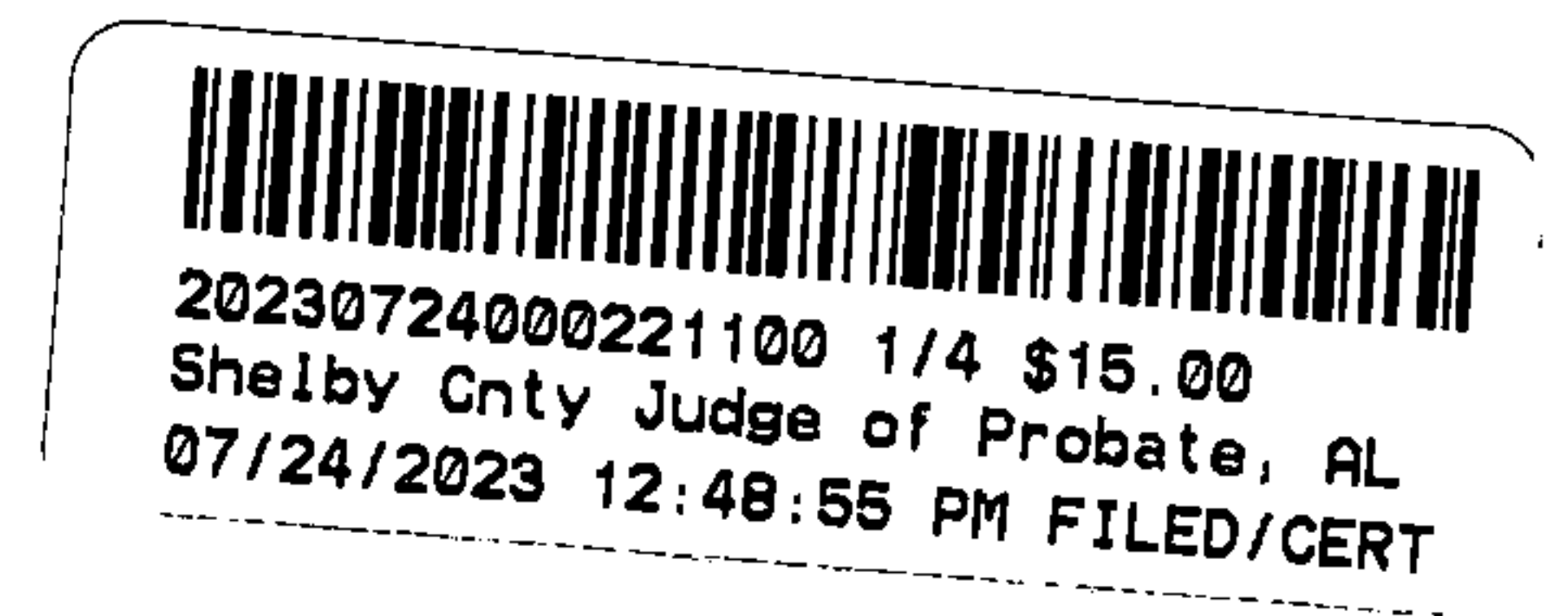

10. To the best of the Trustees knowledge, the Trust has not been revoked, modified, or modified in any manner that would cause the representation contained in this Abstract to be incorrect.

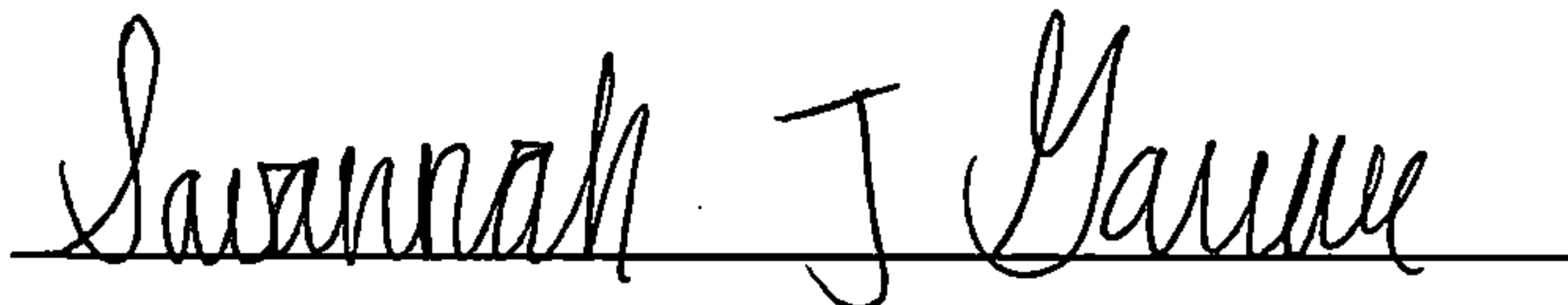

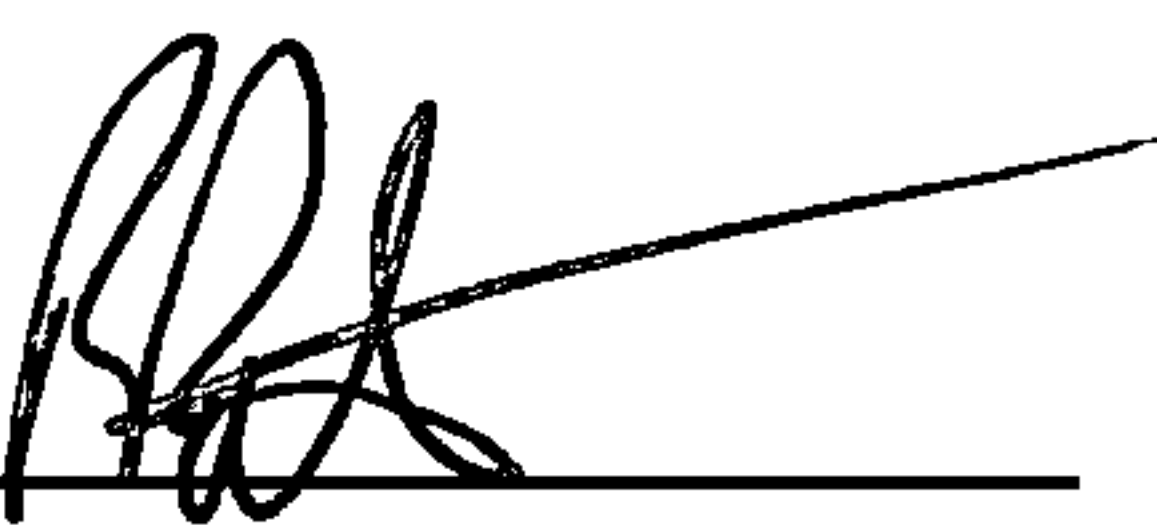
