Map Book 17, Page 96, in the Probate Office of Shelby County, Alabama.

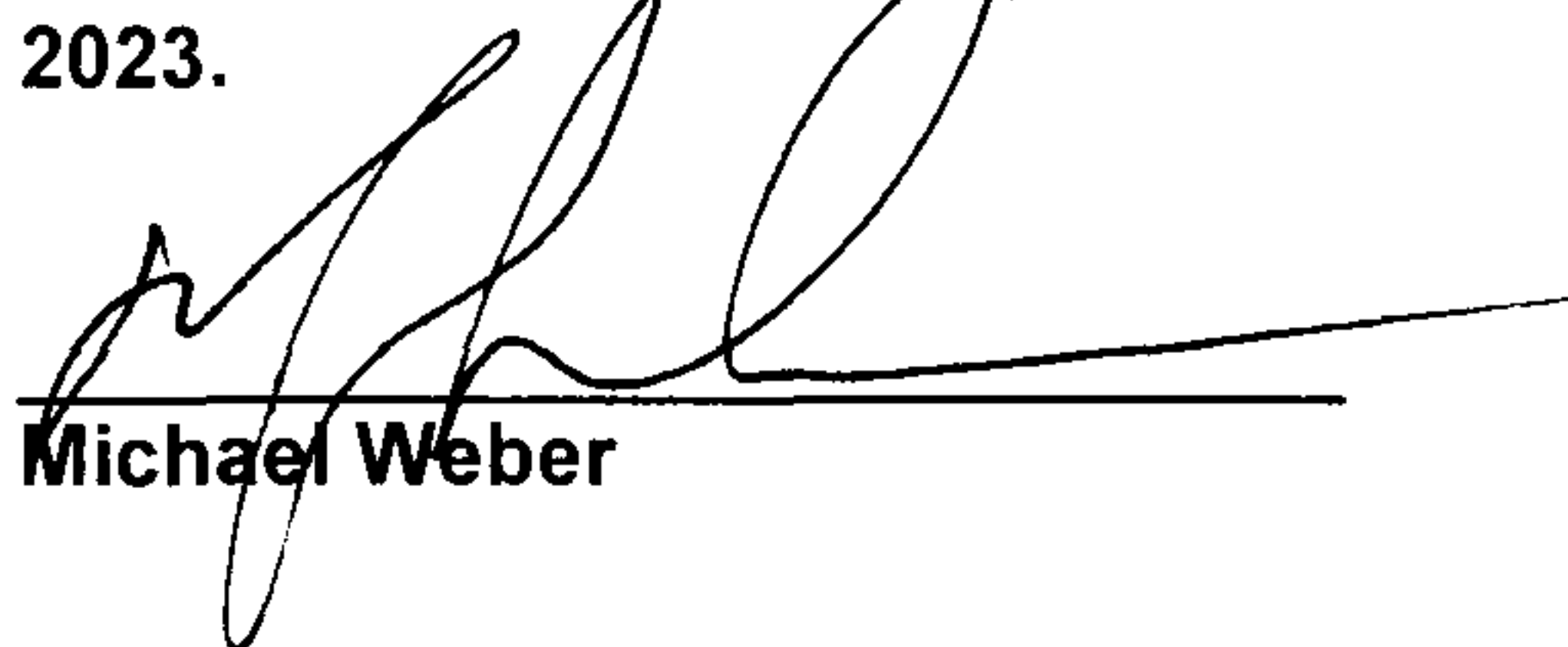

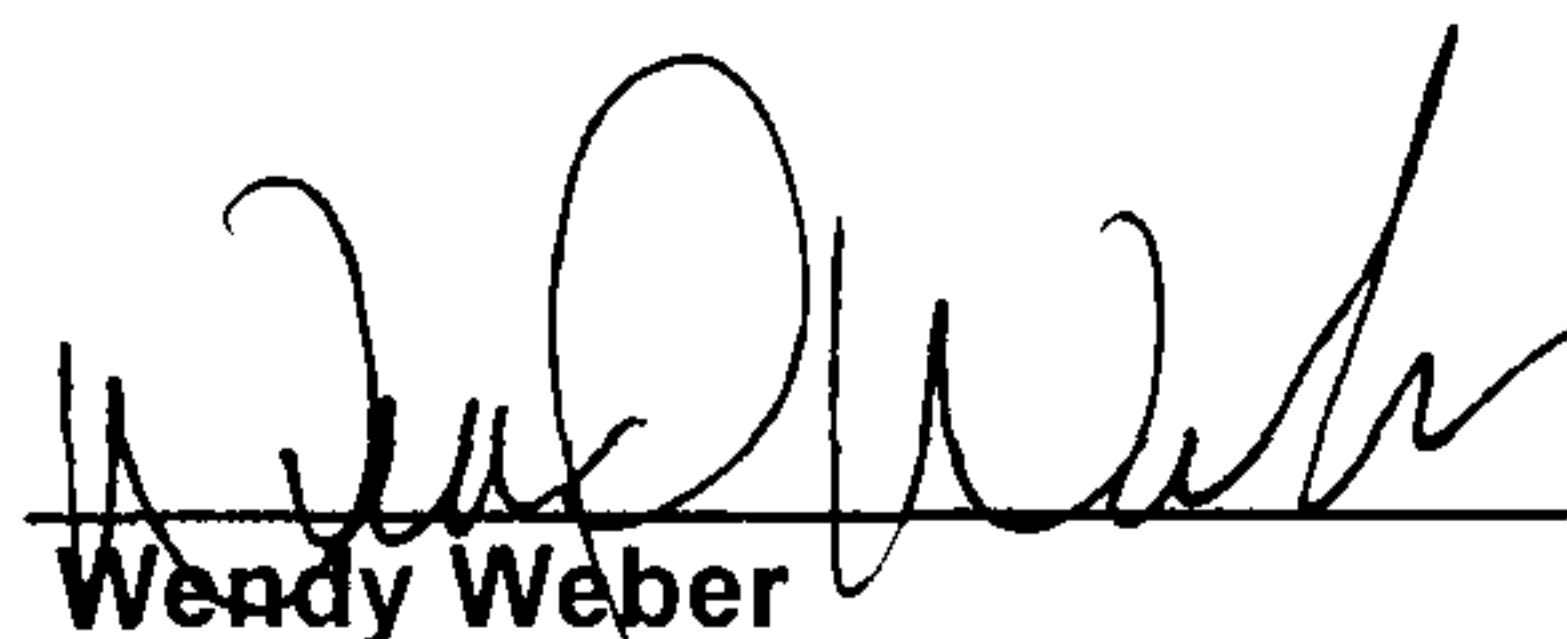
