**ORDER AUTHENTICATING FOREIGN JUDGMENT AGAINST DEFENDANTS  
GLOBAL INVESTIGATIVE SOLUTIONS LLC d/b/a GLOBAL INVESTIGATIVE  
SOLUTIONS AND JAMES BROOKS**

This action comes before the Court on Plaintiff's Notice of Filing of Foreign Judgment, filed on May 8, 2023, by the Foreign Judgment Creditor, Colonial Funding Network, Inc. (Plaintiff), against Foreign Judgment Defendants, Global Investigative Solutions LLC d/b/a Global Investigative Solutions and James David Brooks (Defendants). The Court takes judicial notice of the court file and has reviewed this action and accompanying documents to determine if the requirements of Alabama's Uniform Enforcement of Foreign Judgment Act, Alabama Code §§ 6-9-230–238 are satisfied. Having done so, the Court **FINDS** that the aforementioned requirements have been satisfied. The court has also reviewed Defendant James Brooks' Defendant's Notice to Filing of Foreign Document with a Fraudulent Signature Document and Defendants Answer to Plaintiffs Notice To Filing Of Foreign Judgment and Motion to Quash/Dismiss, as well as Plaintiff's response to those pleadings.

While the court previously granted Defendant James David Brooks' request for oral argument on his motions, it is now satisfied that the relief requested is due to be denied as a matter of law as this court lacks authority to grant the relief requested. Accordingly, those

motion are hereby DENIED and the hearing addressed to same, previously scheduled for August 3, 2023, is hereby CANCELLED.

Accordingly, it is hereby **ORDERED** and **ADJUDGED**, as follows:

1. Pursuant to Ala. Code §§ 6-9-232 & 233, the FOREIGN JUDGMENT in favor of Plaintiff in the amount of \$8,717.00, with interest at 6.000% from date of judgment until paid, \$112.00 in costs, and \$2,179.25 in attorney's fees, is PROPERLY AUTHENTICATED in this court;
2. The herein FOREIGN JUDGMENT has the SAME EFFECT as a JUDGMENT in any Circuit Court of this State, and it may be enforced or satisfied in like manner;
3. The aforementioned FOREIGN JUDGMENT may be RECORDED in any Probate Court of this State as provided for judgments of the Circuit Courts of this State, and such filing shall have the SAME FORCE and EFFECT as the filing of a Certificate of Judgment obtained in a Circuit Court of this State;
4. In that this ORDER is entered more than thirty (30) days from the date of filing of Plaintiff's Notice of Filing of Foreign Judgment, pursuant to ALA. CODE § 6-9-233 (c), EXECUTION or other process of ENFORCEMENT MAY ISSUE;
5. This ORDER entirely disposes of this action, and
6. Costs are taxed as paid.
