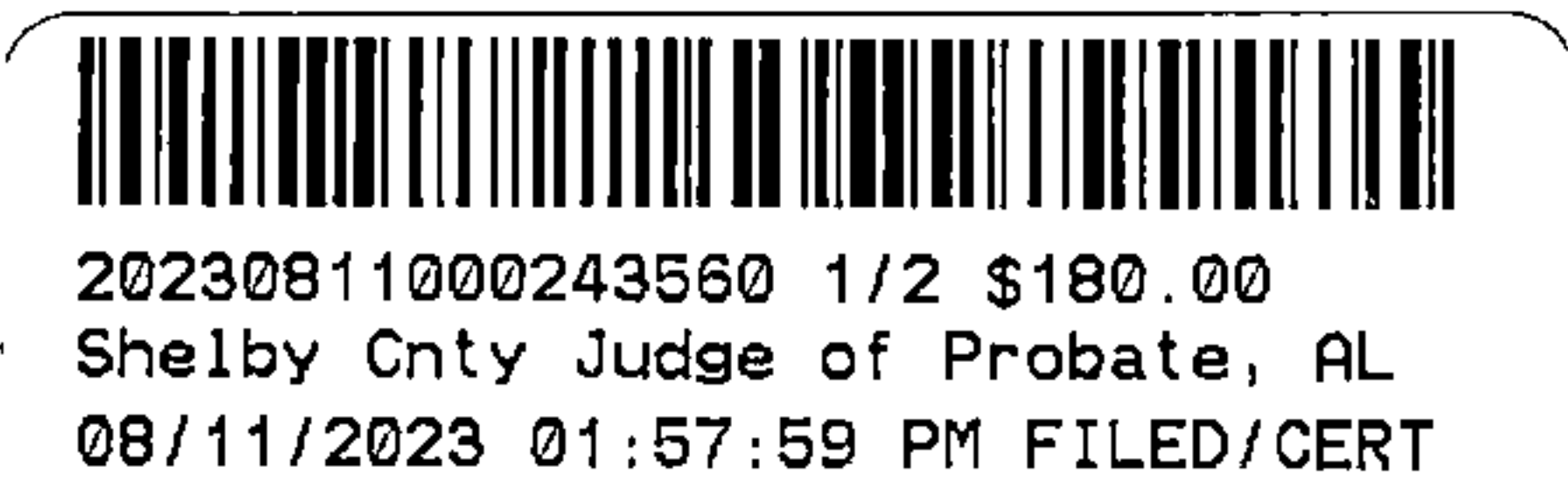

**WARRANTY DEED, JOINT TENANTS WITH RIGHT OF SURVIVORSHIP**

**KNOW ALL MEN BY THESE PRESENTS**, That in consideration **ONE HUNDRED FIFTY FOUR THOUSAND NINE HUNDRED FIFTY DOLLARS (\$154,950.00)**, and other good and valuable considerations to the undersigned grantor (whether one or more), in hand paid by grantee herein, the receipt whereof is acknowledged, I or we, **Lisa Howard, a single woman** (herein referred to as **Grantor**) grant, bargain, sell and convey unto **Lisa Howard and Chrisie Howard, as joint tenants with right of survivorship** (herein referred to as **Grantees**), the following described real estate, situated in: **SHELBY County, Alabama**, to-wit:

Lot 54, according to the survey of Thorn Berry Subdivision, as recorded in Map Book 25, Page 129, in the Probate Office of Shelby County, Alabama.

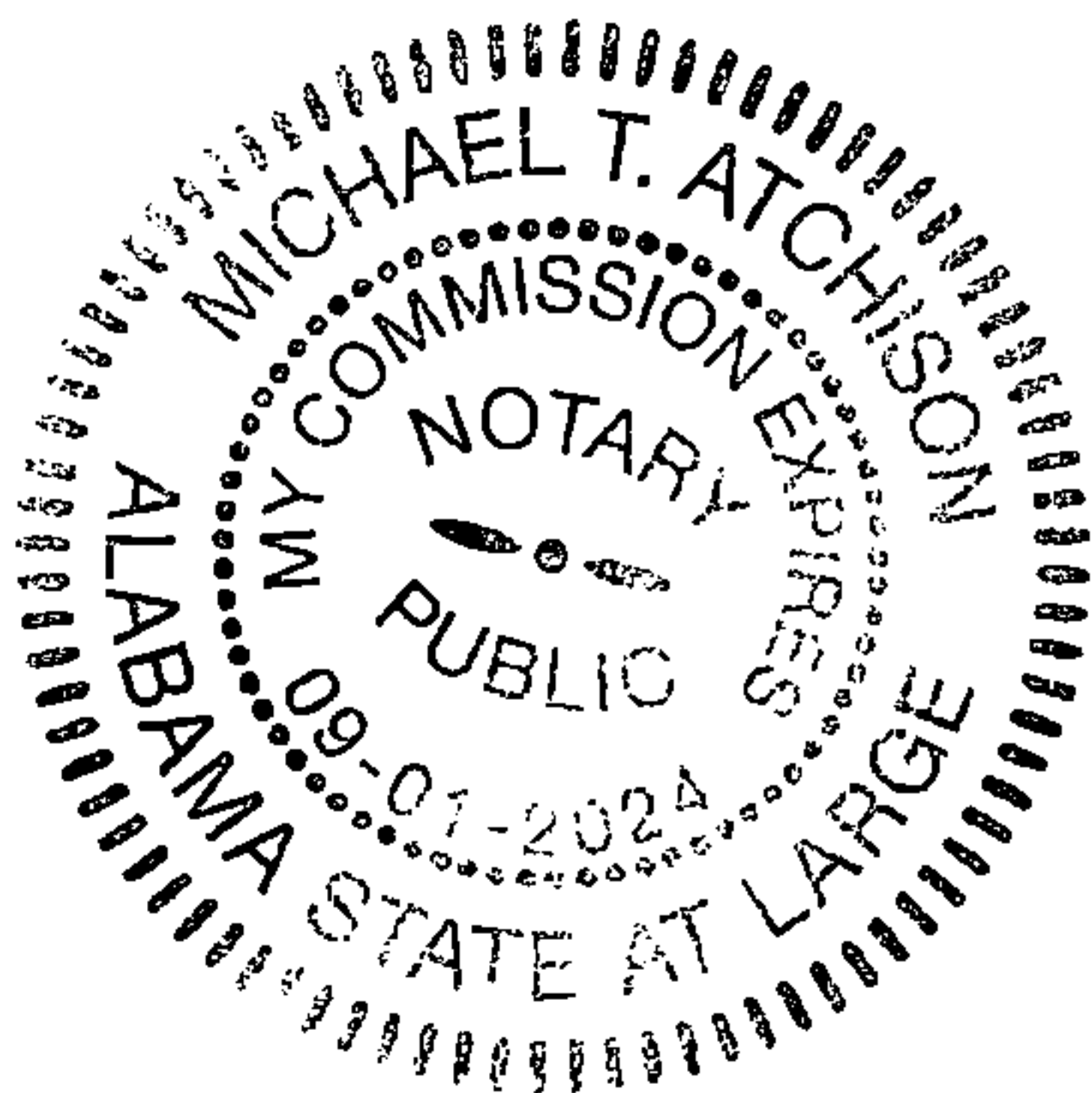
