That in consideration of the sum of **Two Hundred Twenty Two Thousand Dollars and No Cents (\$222,000.00)**, the amount of which can be verified in the Sales Contract between the parties hereto, to the undersigned Grantor (whether one or more), in hand paid by the Grantee herein, the receipt whereof is acknowledged, I or we, **Carl D Skinner and Sara M Skinner**, husband and wife (herein referred to as Grantor, whether one or more), grant, bargain, sell and convey unto **Tauna Johnson, Donna-Mae M. Pahukoa, and Dean E. Loper, joint tenants with Right of Survivorship** (herein referred to as Grantee, whether one or more), the following described real estate, situated in Shelby, County, Alabama, to wit;

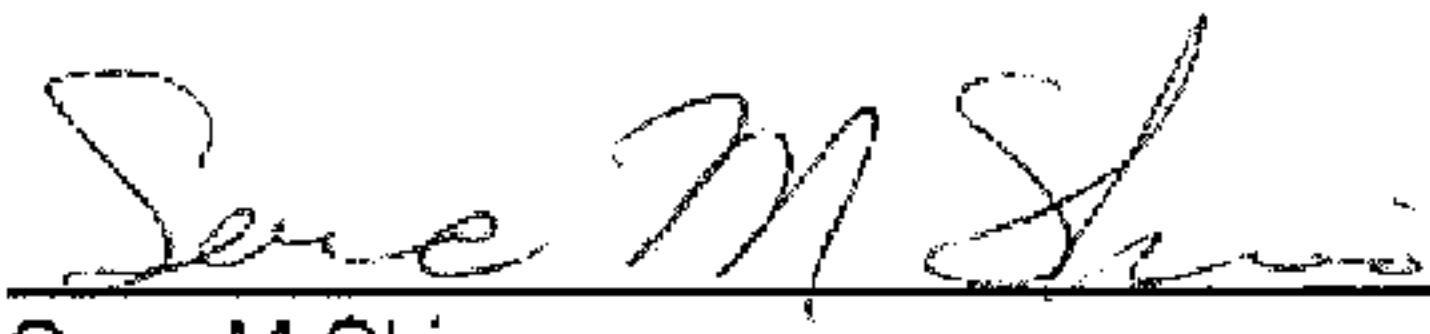
\$0.00 of the purchase price of the above described property was financed with the proceeds of a mortgage loan closed simultaneously herewith.

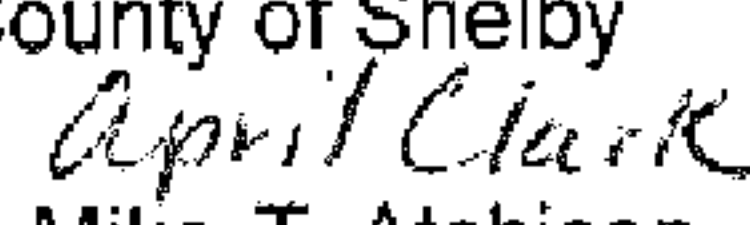

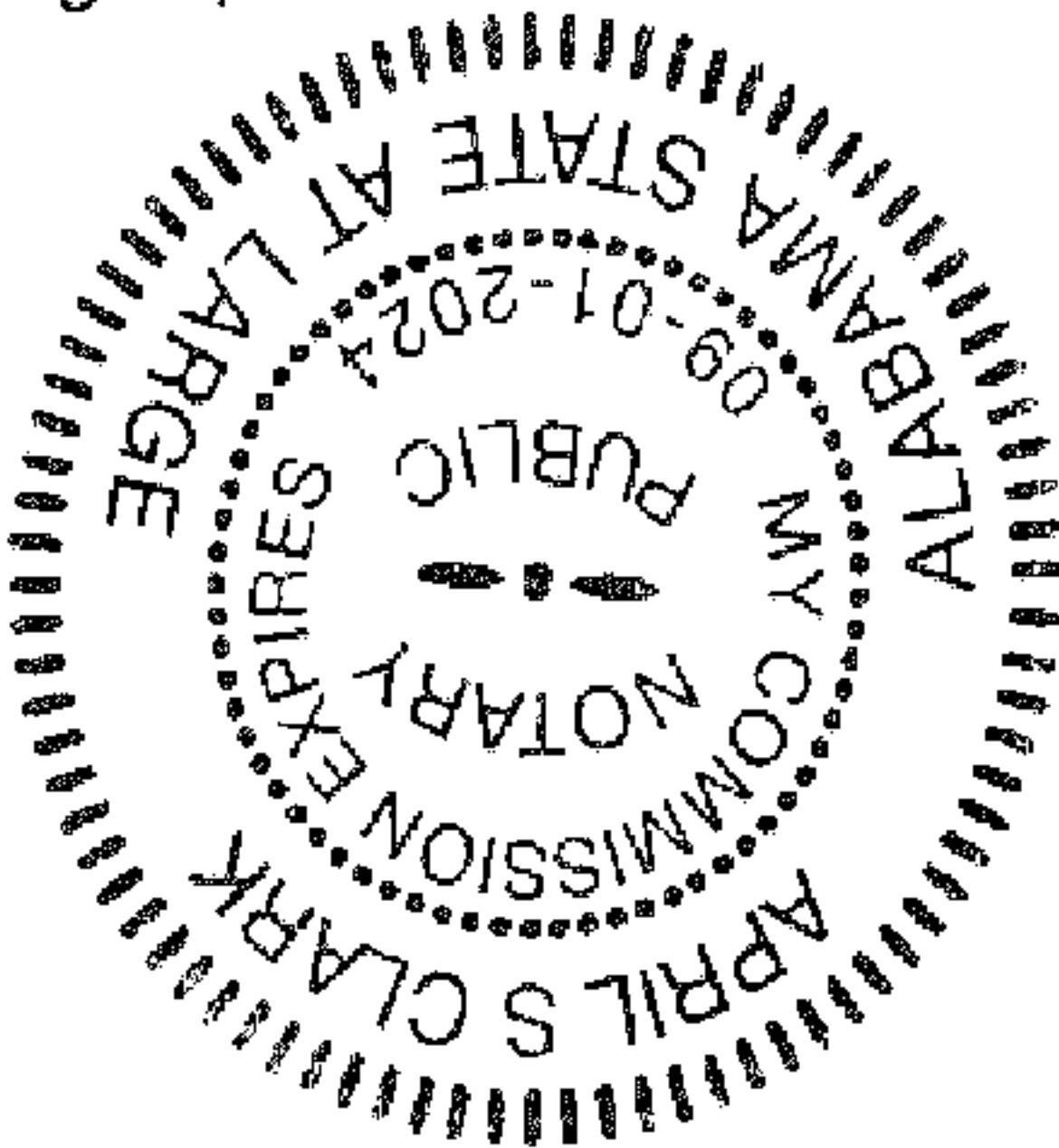
