Subject to taxes for the current year and any easements, restrictions or reservation of record.

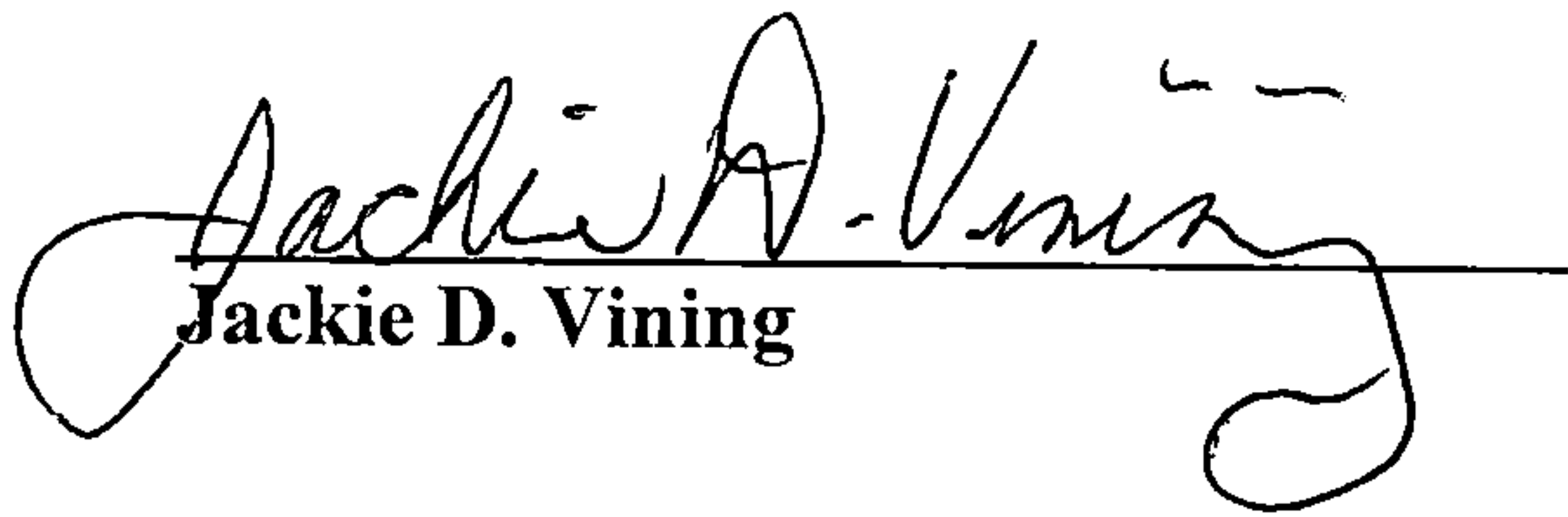

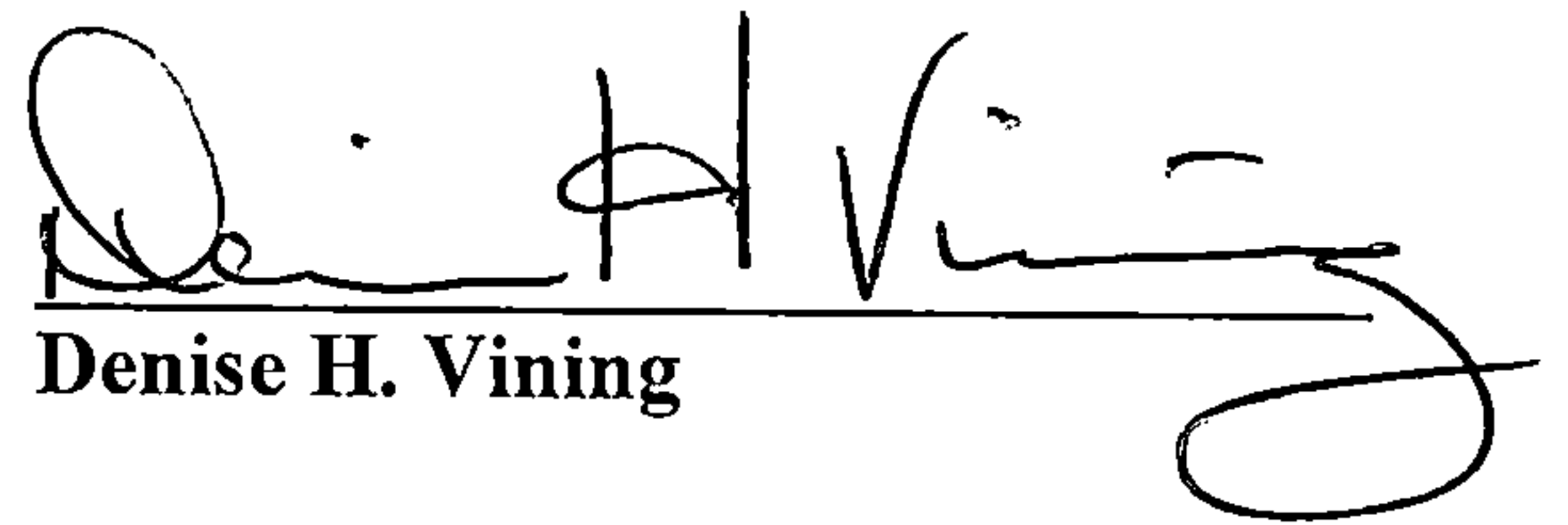

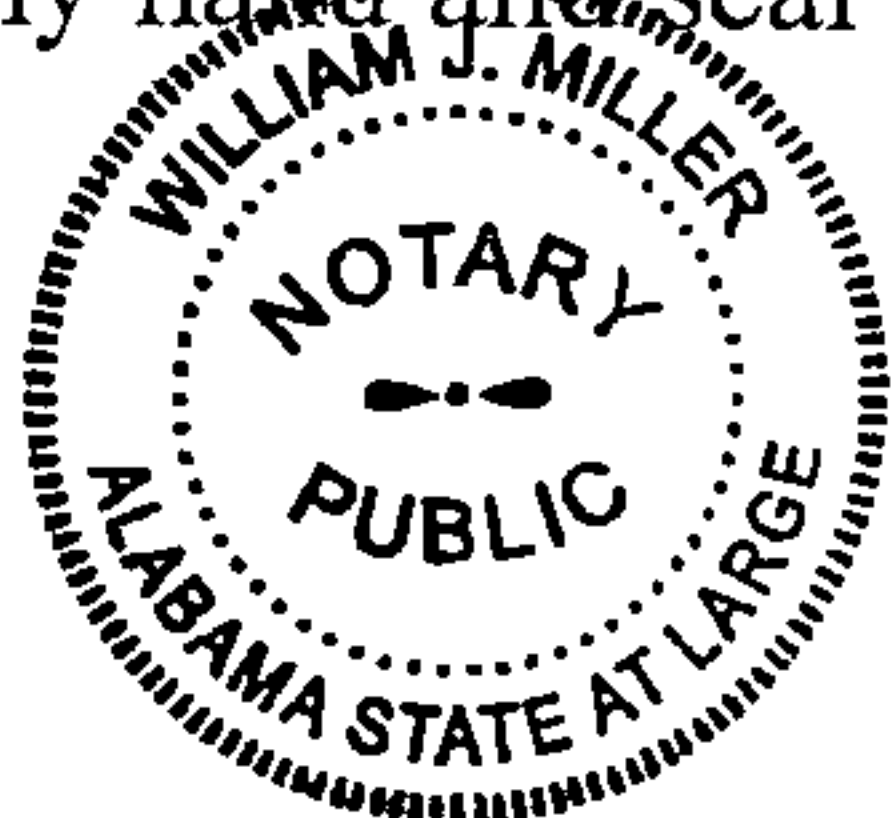
