See Exhibit "A" attached hereto and made a part hereof by reference.



**TO HAVE AND TO HOLD,** to the said GRANTEE, her heirs and assigns forever.





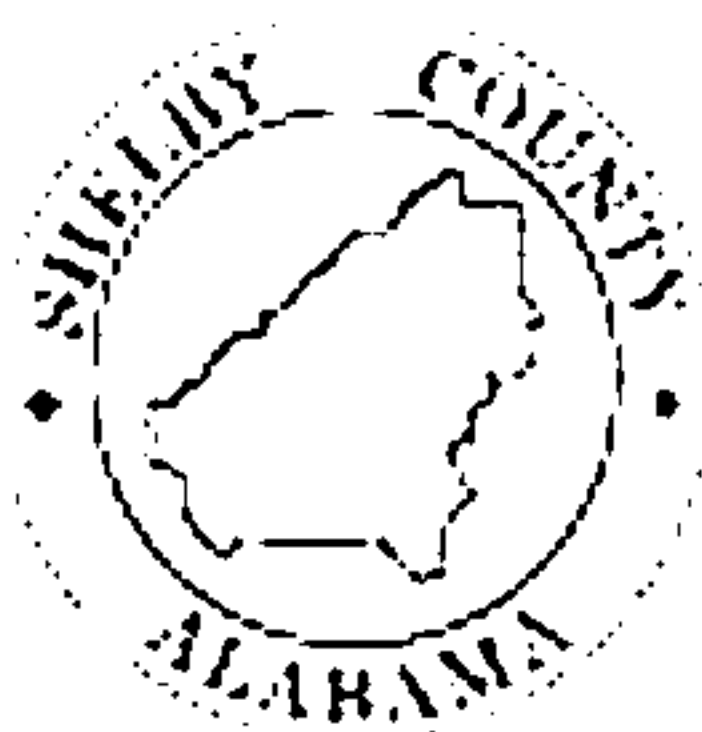
