That in consideration of the sum of **One Hundred Fifty Thousand Dollars and No Cents (\$150,000.00)**, the amount of which can be verified in the Sales Contract between the parties hereto, to the undersigned Grantor (whether one or more), in hand paid by the Grantee herein, the receipt whereof is acknowledged, I or we, **Alton Keith Sims, a married man**, (herein referred to as Grantor, whether one or more), grant, bargain, sell and convey unto **Jacob Deitrick and Ashley Deitrick, as joint tenants with right of survivorship** (herein referred to as Grantee, whether one or more), the following described real estate, situated in Shelby, County, Alabama, to wit:

No part of the homestead of the spouse of the Grantor herein.
\$145,500.00 of the purchase price of the above described property was financed with the proceeds of a mortgage loan closed simultaneously herewith.

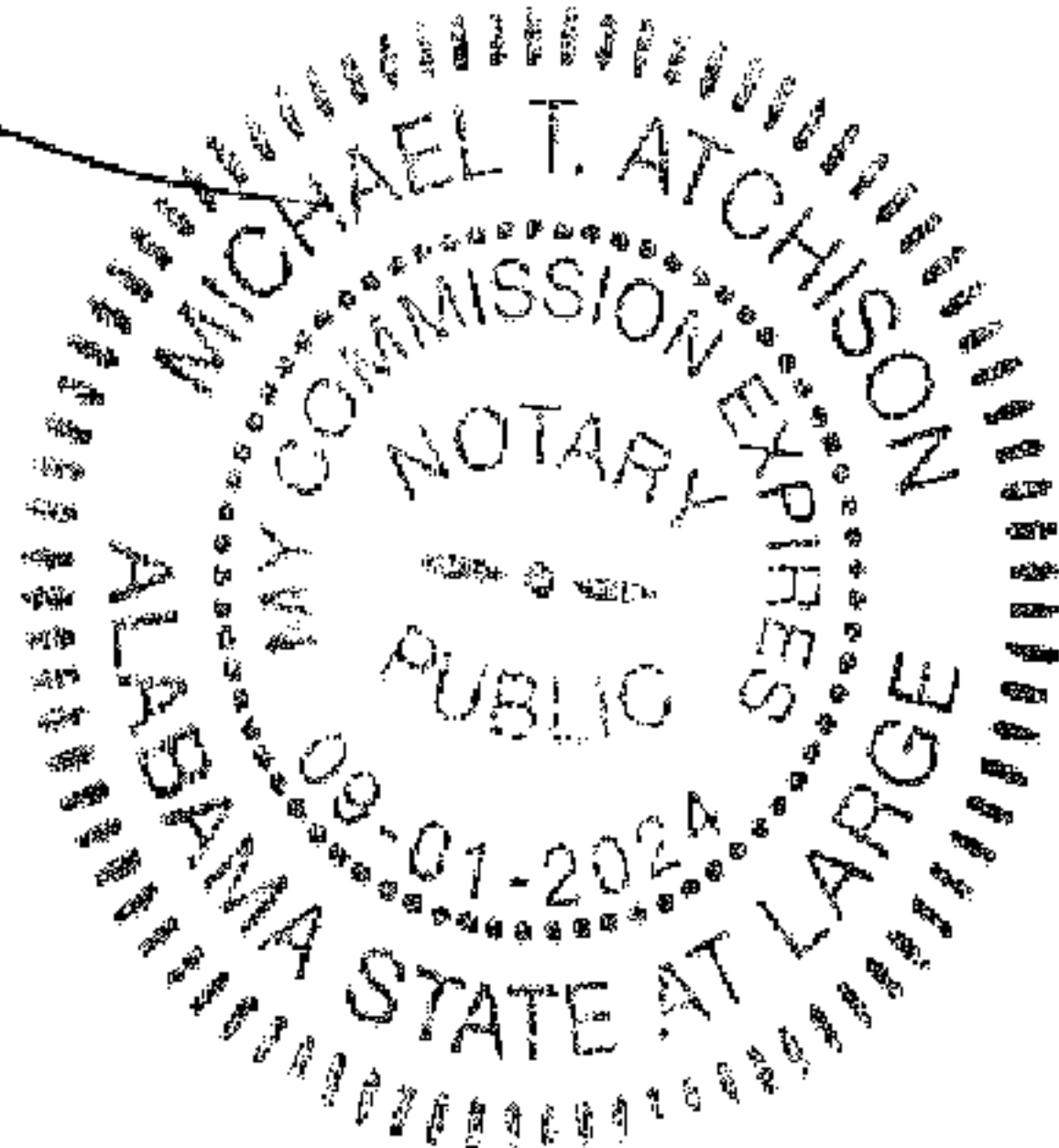


EXHIBIT "A"
LEGAL DESCRIPTION
