

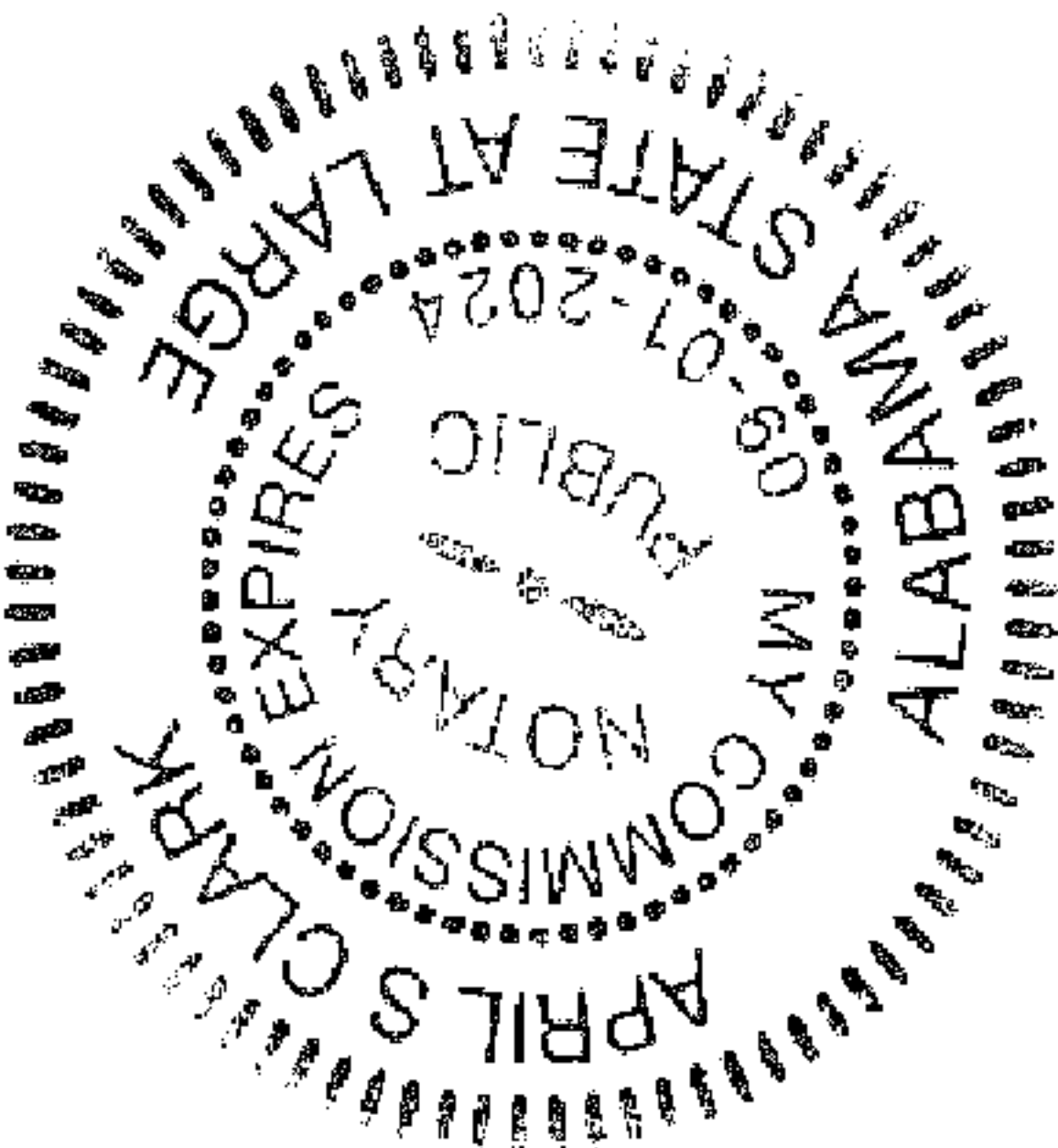

**LEGAL DESCRIPTION**
