Shaw as follows: Beginning at the Northwest corner of the Tom McGaughy Lot and run North along the right of way of the Southern Railway track a distance of 105 feet; Thence the Point of Beginning; Thence continue along said right of way 105 feet; Thence East 339 feet; Thence South 105 feet; Thence West 250 feet, to the Point of Beginning, situated in the Northeast quarter of Section 19, Township 22, Range 3 West, Map of which is record 3, Page 49, in the Probate Office of Shelby County, Alabama. 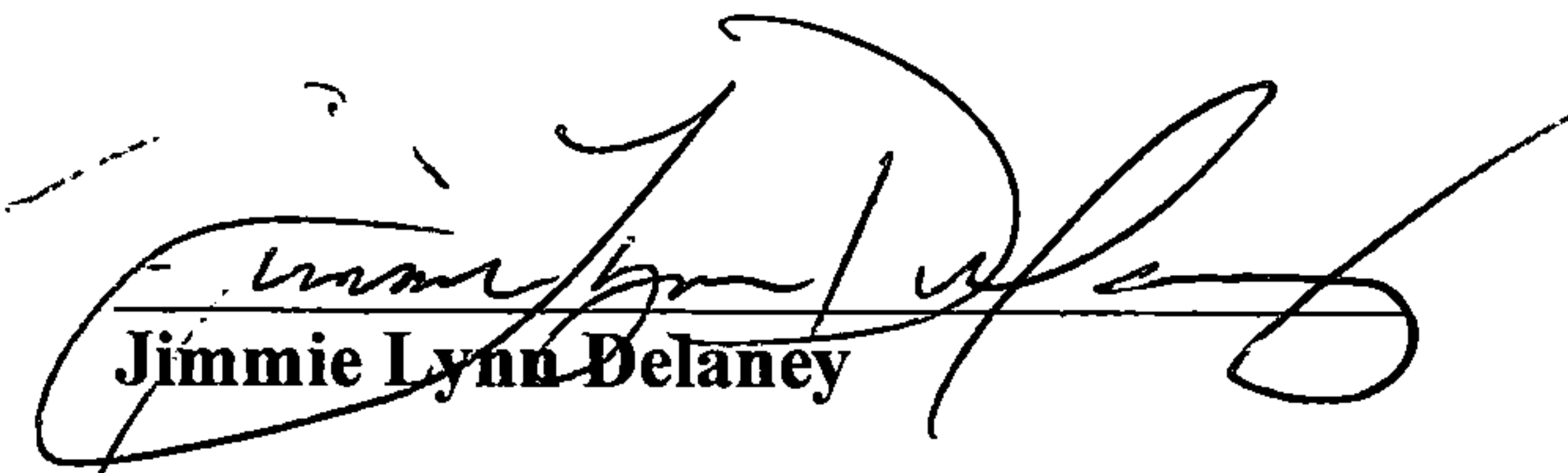

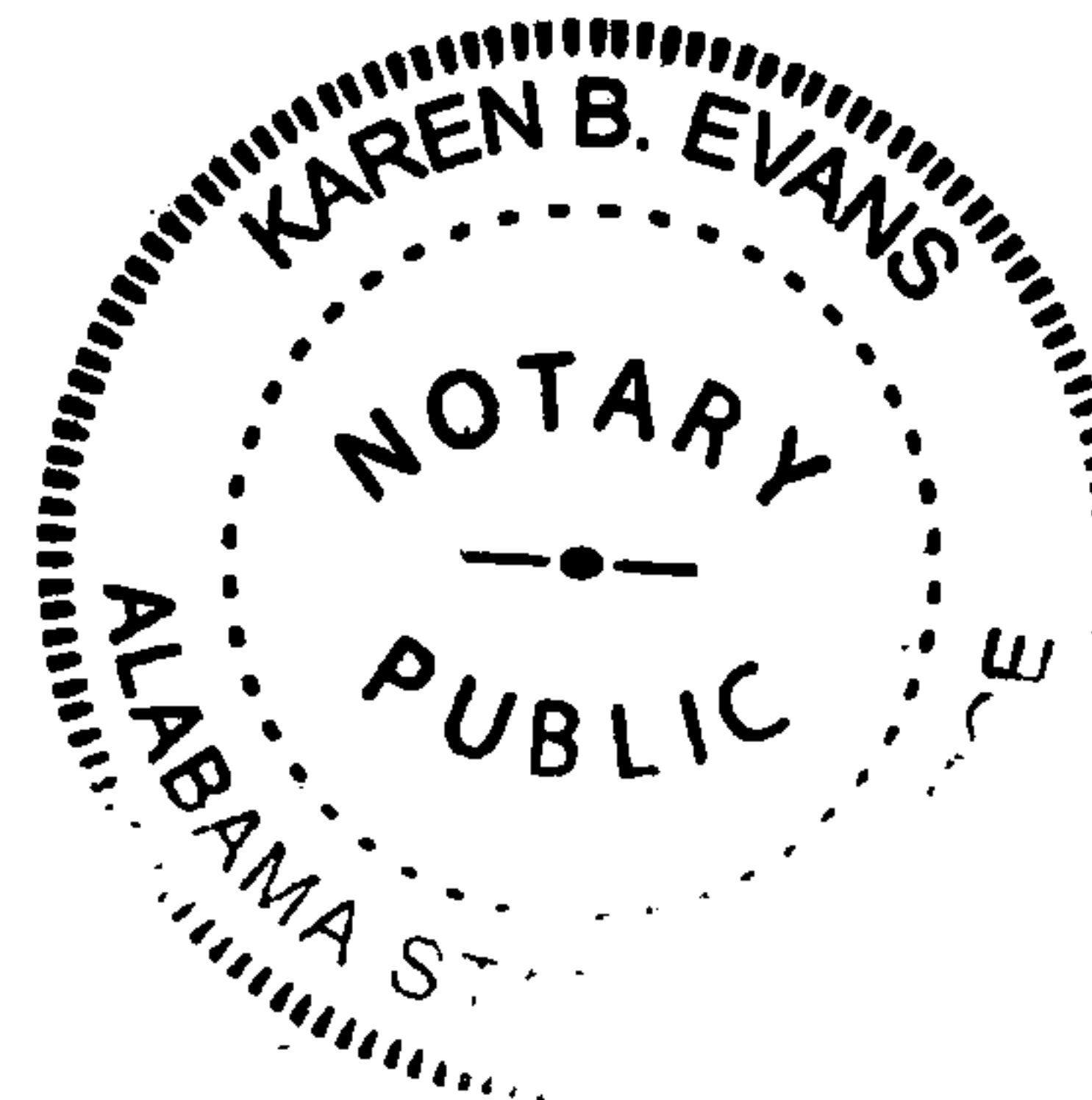
