KNOW ALL MEN BY THESE PRESENTS, That in consideration of Three Hundred Ninety Thousand and 00/100 Dollars (\$390,000.00), being the contract sales price, to the undersigned Grantors in hand paid by the Grantee herein, the receipt of which is hereby acknowledged,

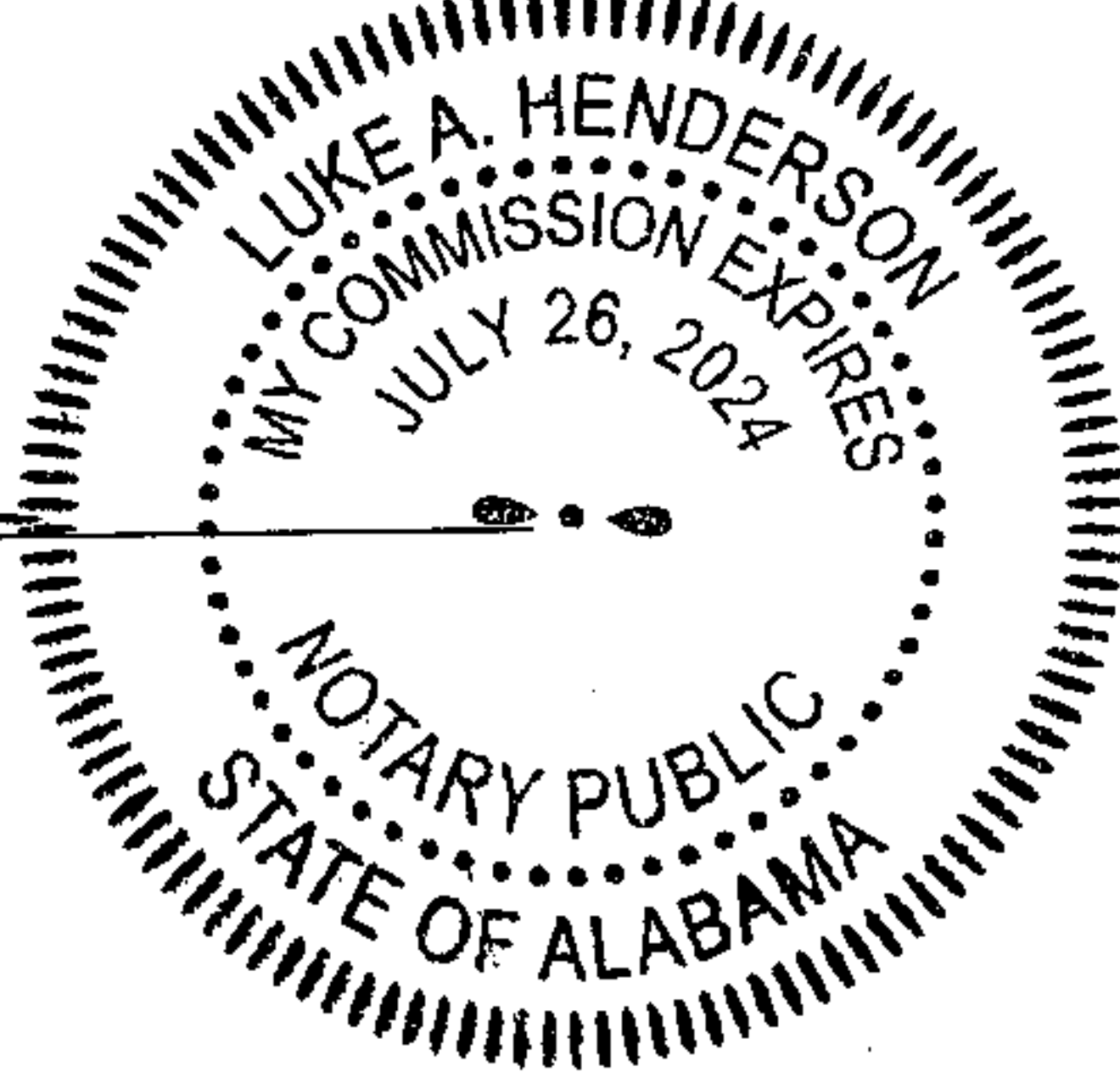
