FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on to wit, July 30, 2021, Pierre A Tisbe, a single man, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc., solely as nominee for Guild Mortgage Company LLC, which said mortgage was recorded in Instrument Number 20210802000371640 in the Office of the Judge of Probate of Shelby County, Alabama; said mortgage subsequently transferred and assigned to Guild Mortgage Company LLC by instrument recorded in Instrument Number 20230724000221080 in the aforesaid Probate Office Transferee and

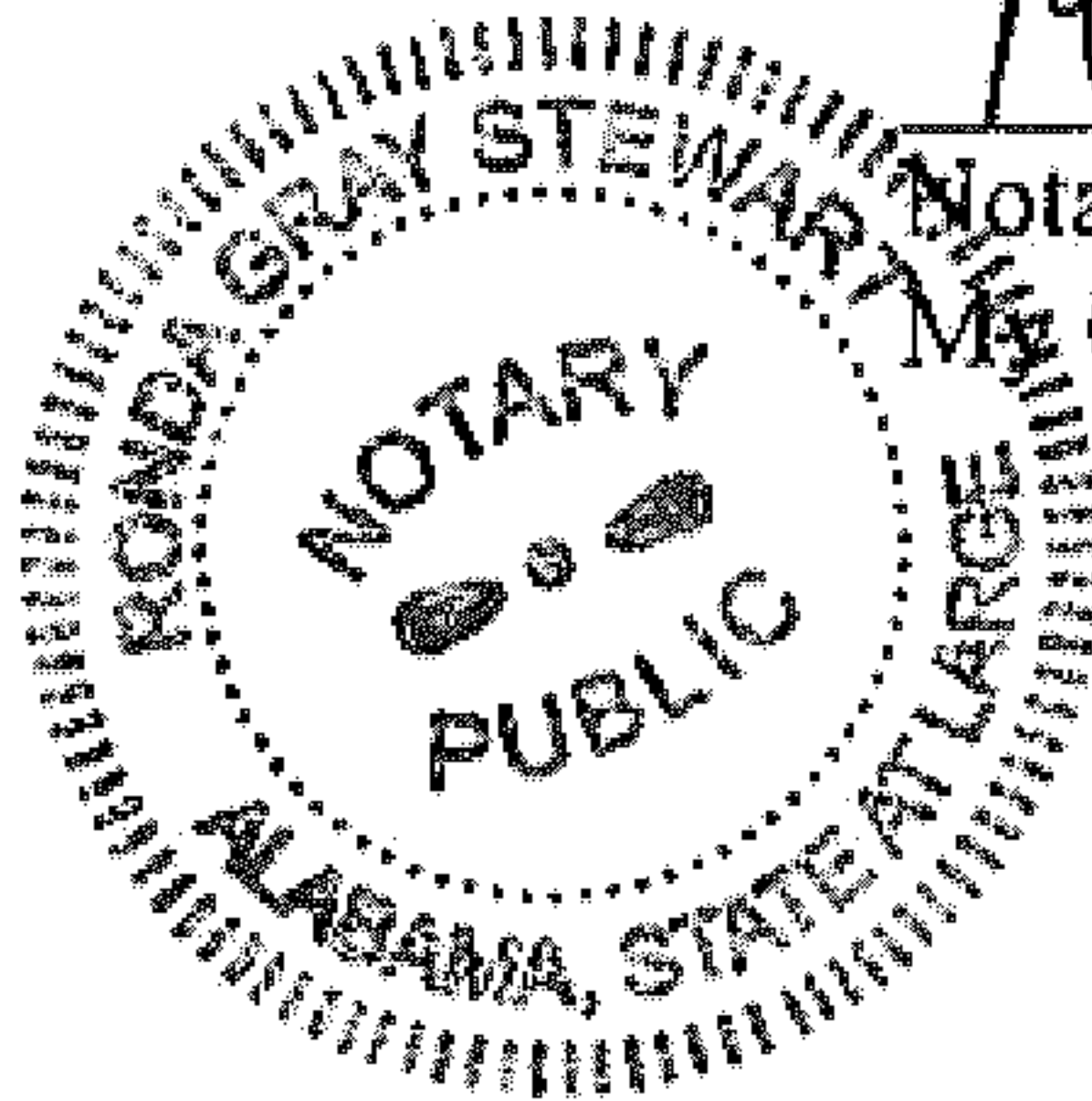

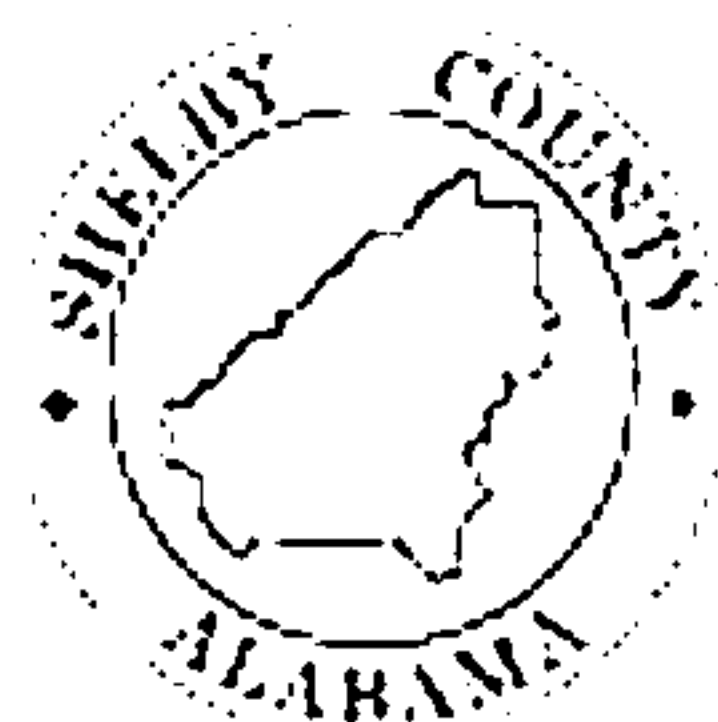
