JOINTLY FOR LIFE WITH REMAINDER TO SURVIVOR

} Know All Men by These Presents:

County of Shelby

That in consideration of the sum of **Two Hundred Thousand Dollars and No Cents (\$200,000.00)**, the amount of which can be verified in the Sales Contract between the parties hereto, to the undersigned Grantor (whether one or more), in hand paid by the Grantee herein, the receipt whereof is acknowledged, I or we, **Mary Ann Griffin**, a single woman (herein referred to as Grantor, whether one or more), grant, bargain, sell and convey unto **Robert Lee Reagan and Robert Lee Reagan Jr.**, as joint tenants with right of survivorship (herein referred to as Grantee, whether one or more), the following described real estate, situated in Shelby, County, Alabama, to wit;

Lot 28 according to the Survey of Walters Cove, First Sector, as recorded in Map Book 5, Page 22, in the Probate Office of Shelby County, Alabama.

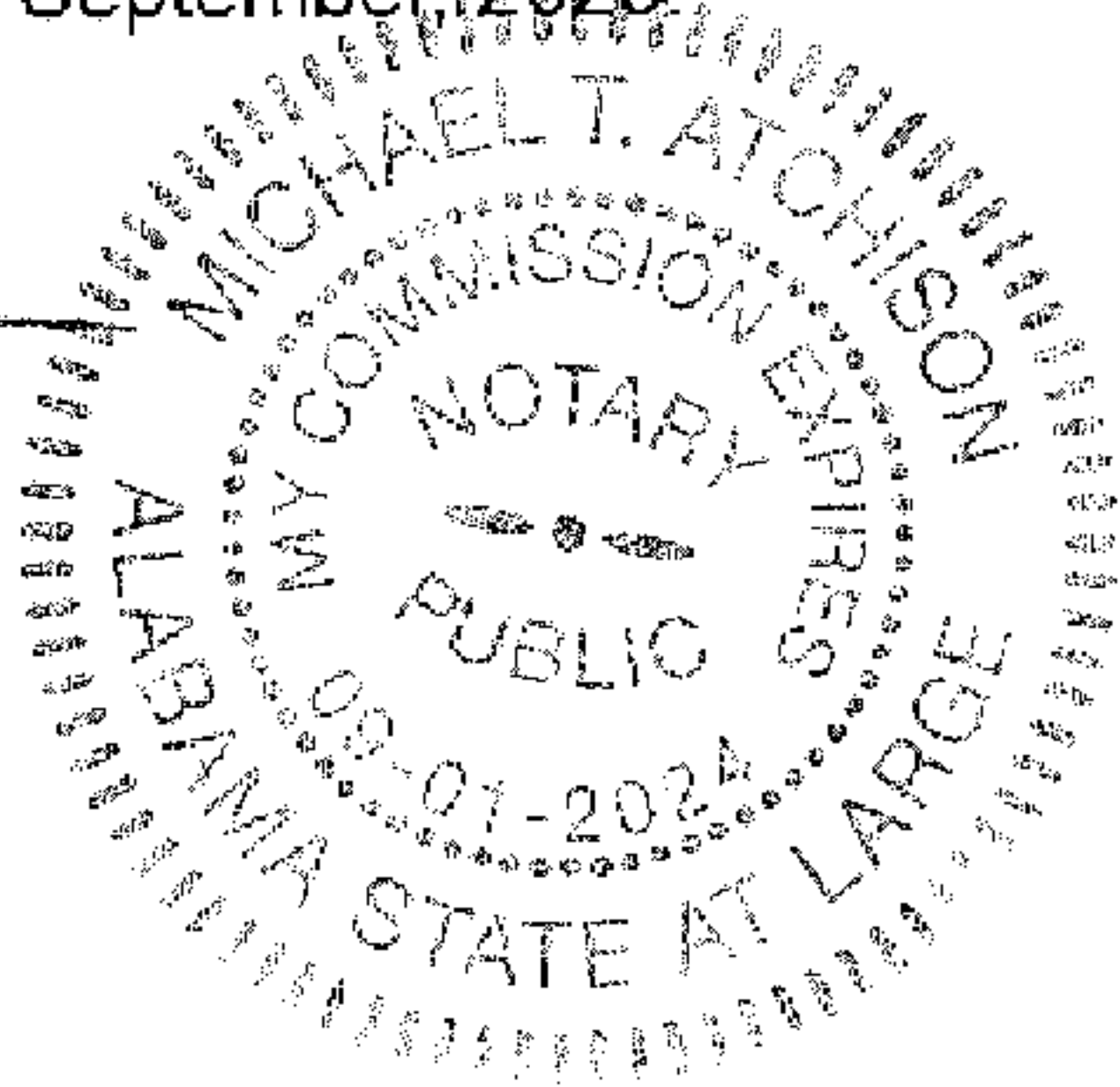
