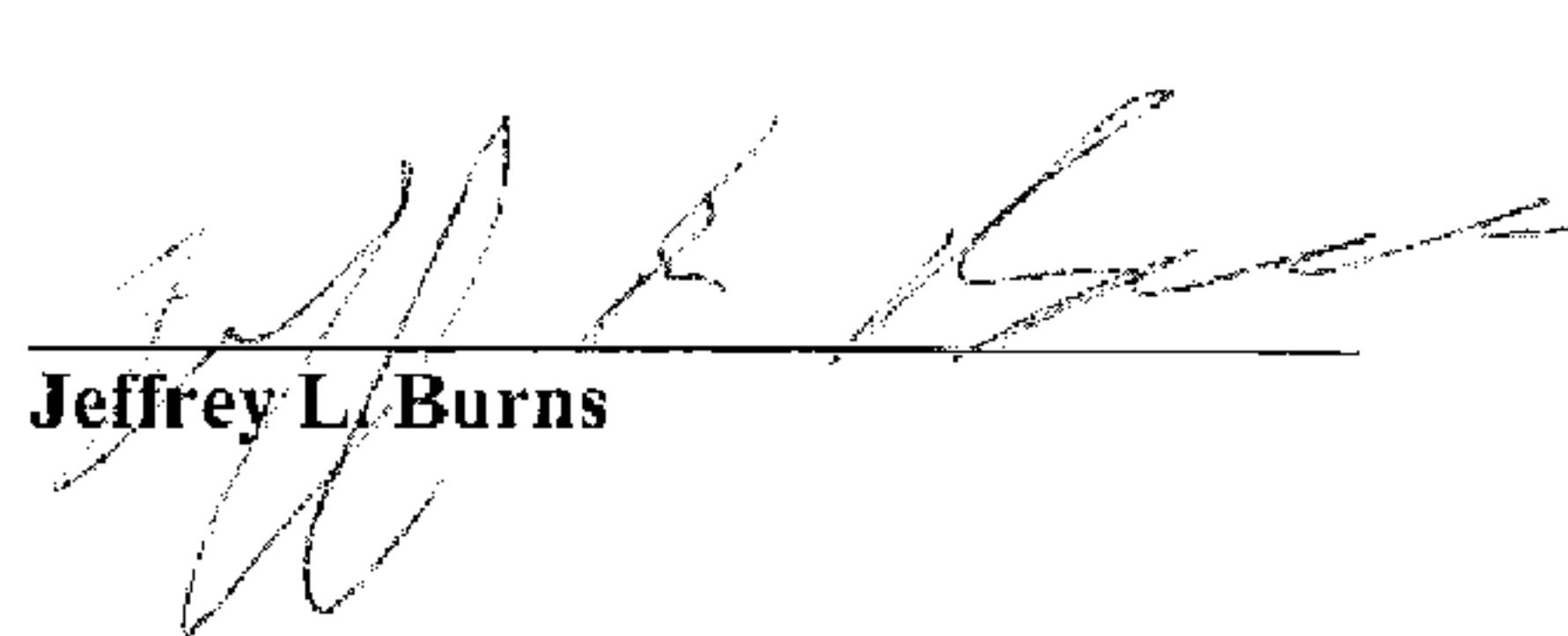
SEE ATTACHED EXHIBIT "A" – LEGAL DESCRIPTION

EXHIBIT A – LEGAL DESCRIPTION**Parcel 1**

Lot 62, according to the Survey of A Subdivision for Single Family Residences, Bully Creek Farm Development 1st Sector, as recorded in Map Book 38, Page 75A and 75B, in the Probate Office of Shelby County, Alabama.

Parcel 2

Part of the W 1/2 of NE 1/4 of Section 22, Township 21 South, Range 1 East, Shelby County, Alabama, being more particularly described as follows: From the Southeast corner of said 1/4-1/4 section, run in a westerly direction along the South line of said 1/4-1/4 section for a distance of 417.50 feet to an existing iron pin being the point of beginning; thence continue along last mentioned course for a distance of 461.69 feet to an existing iron pin; thence turn an angle to the right of 90 degrees 03 minutes and run in a northwesterly direction for a distance of 1,147.76 feet to an existing iron pin being on the southeasterly right of way line of Shelby County Road #61; thence turn an angle to the right (58 degrees 05 minutes to chord) and run in a northeasterly direction for a distance of 294.08 feet; thence turn an angle to the left of 2 degrees 49 minutes (from last mentioned chord line) and run in a northeasterly direction along said southeast right of way line for a distance of 232.44 feet to an existing iron pin; thence turn an angle to the right of 123 degrees 53 minutes 36 seconds and run in a southerly direction for a distance of 1,435.42 feet, more or less, to the point of beginning. Situated in Shelby County, Alabama.
