FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on to wit, October 26, 2018, Jospheh Carrol Kelly III and Samantha Kelly, husband and wife, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc. solely as nominee for American Financial Resources, Inc., which said mortgage was recorded in Instrument Number 20181026000381060 in the Office of the Judge of Probate of Shelby County, Alabama; said mortgage subsequently transferred and assigned to MidFirst Bank by instrument recorded in Instrument No. 20221109000419120 in the aforesaid Probate Office (hereafter "Transferee"); and

WHEREAS, on October 2, 2023, the day on which the foreclosure was due to be held under the terms of said notice, between the legal hours of sale, said foreclosure was duly conducted, and MidFirst Bank did offer for sale and sell at public outcry in front of the Courthouse door in Columbiana, Shelby County, Alabama, the property hereinafter described; and




