ORDER REVOKING LETTERS & FOR BOND COMPANY TO PAY BOND AMOUNT INTO COURT PENDING FINAL SETTLEMENT

A Petition For Consent Settlement was filed in this matter on September 16, 2021 along with consents to settlement signed by Martha Lollar and Frances L. Hughes. Although the Petition indicated that there were consents from all heirs at law, it appears from the Court record that a consent was not obtained from Kella Marie Horton. A Petition for Final Settlement was then filed with the Court on November 15, 2021 which included supporting Schedules evidencing that the Personal Representative was chargeable with receipts in the amount of \$3,000.00 and due to be credited with payments of \$0.00. The Personal Representative reported a balance on hand of \$0.00. The attached Schedules indicate that \$3,000.00 was "Balance left in Court 2007 Ford Escape". The Court records do not reflect any monies being on deposit with the Court in it's fiduciary account for the benefit of this estate.

On November 17, 2021, Michael T. Atchison, Esq., as attorney of record for the estate filed a Motion To Withdraw Petition For Final Settlement of Decedents Estate, indicating that the estate needed to remain open due to pending wrongful death asbestos litigation filed on behalf of the Estate of Marshel Hughes. The Court entered an Order Granting the Motion and requiring the filing of an Annual Accounting within thirty (30) days. The Accounting was not filed.

The Court entered an Order to File Annual Accounting on January 17, 2023. The attorney of record, Michael T. Atchison, Esq., filed a Motion To Withdraw on February 9, 2023 which was granted on February 16, 2023 in an Order which required the Personal Representative to file an
