

KNOW ALL MEN BY THESE PRESENTS, that in consideration of Six Hundred Seventy Six Thousand Nine Hundred and No/100 Dollars (\$676,900.00) to the undersigned grantor, RIDGE CREST HOMES, LLC, an Alabama limited liability company, in hand paid by Grantee named herein, the receipt of which is hereby acknowledged, the said RIDGE CREST HOMES, LLC, an Alabama limited liability company, by these presents, grant, bargain, sell and convey unto Quardarius Dajuan Williams and Bria Nichole Williams (hereinafter referred to as "Grantee", whether one or more), for and during their joint lives and upon the death of either, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, the following described real estate (the "property"), situated in Shelby County, Alabama, to-wit:

And said Grantor does for itself, its successors and assigns covenant with said Grantees, their heirs and assigns that it is lawfully seized in fee simple of said premises, that they are free from all encumbrances, unless otherwise noted above, that it has good right to sell and convey the same as aforesaid, and that it will and its successors and assigns shall, warrant and defend the same to the said Grantees, their heirs, executors and assigns forever, against the lawful claims of all persons.
