Exhibit A-Legal Description


A parcel of land situated in the Northeast quarter of Section 26, Township 21 South, Range 1 West, City of Columbiana, Shelby County, Alabama, being more particularly described as follows:

Commence at and iron pin found at the intersection of the South right of way margin of Butler Street and the West right of way margin of Collins Street in the Town of Columbiana, Alabama, said point being the POINT OF BEGINNING; thence proceed Westerly along the South right of way margin of Butler street for 424.79 feet to an iron pin found on the Easterly line of "J.H. Compton Subdivision" as recorded in Map Book 3, Page 16 if the Office of the Judge of Probate, Shelby County, Alabama; thence turn an angle left of 110 degrees 52 minutes 50 seconds and proceed Southeasterly along said Easterly line of "J.H. Compton Subdivision" for 759.32 feet to an iron pin found; thence turn an angle right of 36 degree 36 minutes 21 seconds and proceed Southwesterly for 70.32 feet to an iron pin found on the Northerly right of way margin of Depot Street; thence turn an angle left of 73 degrees 30 minutes 13 seconds and proceed Southeasterly along said Northerly right of way margin of Depot Street for 205.25 feet to an iron pin found; thence turn an angle left of 122 degree 14 minutes 56 seconds proceed Northerly for 886.57° to the POINT OF BEGINNING.

LESS that portion lying within the right of way of Collins Street.

LESS AND EXCEPT:

A parcel of land located in the North one-half of the Northeast quarter of Section 26, Township 21 South, Range 1 West, City of Columbiana, Shelby County, Alabama, Beginning at the Easternmost corner of the Emory H. Weathers and Louise S. Weathers property as described in deed recorded in Deed Book 332, Page 198 in the Probate Office of Shelby County, Alabama, which corner is a point on the Easterly line of J.H. Compton Addition to Columbiana, recorded in Map Book 3, Page 16 in the Probate Office of Shelby County, Alabama; from said beginning point run Southeasterly along the extension of the Easterly line of said J.H. Compton's Addition to the Northerly right of way of Depot Street; thence turn right and run Northwesterly along Depot Street to the Southernmost corner of the Weather's property; thence turn right 79 degrees 24 minutes 12 seconds and run Northerly along the Weather's property a distance of 60 feet, more or less, to the point of beginning.
