KNOW ALL MEN BY THESE PRESENTS, That in consideration **ONE HUNDRED THIRTEEN THOUSAND THREE HUNDRED FIFTY AND NO/00 DOLLARS (\$113,350.00)**, and other good and valuable considerations to the undersigned grantor (whether one or more), in hand paid by grantee herein, the receipt whereof is acknowledged, I or we, *Rosalie M. 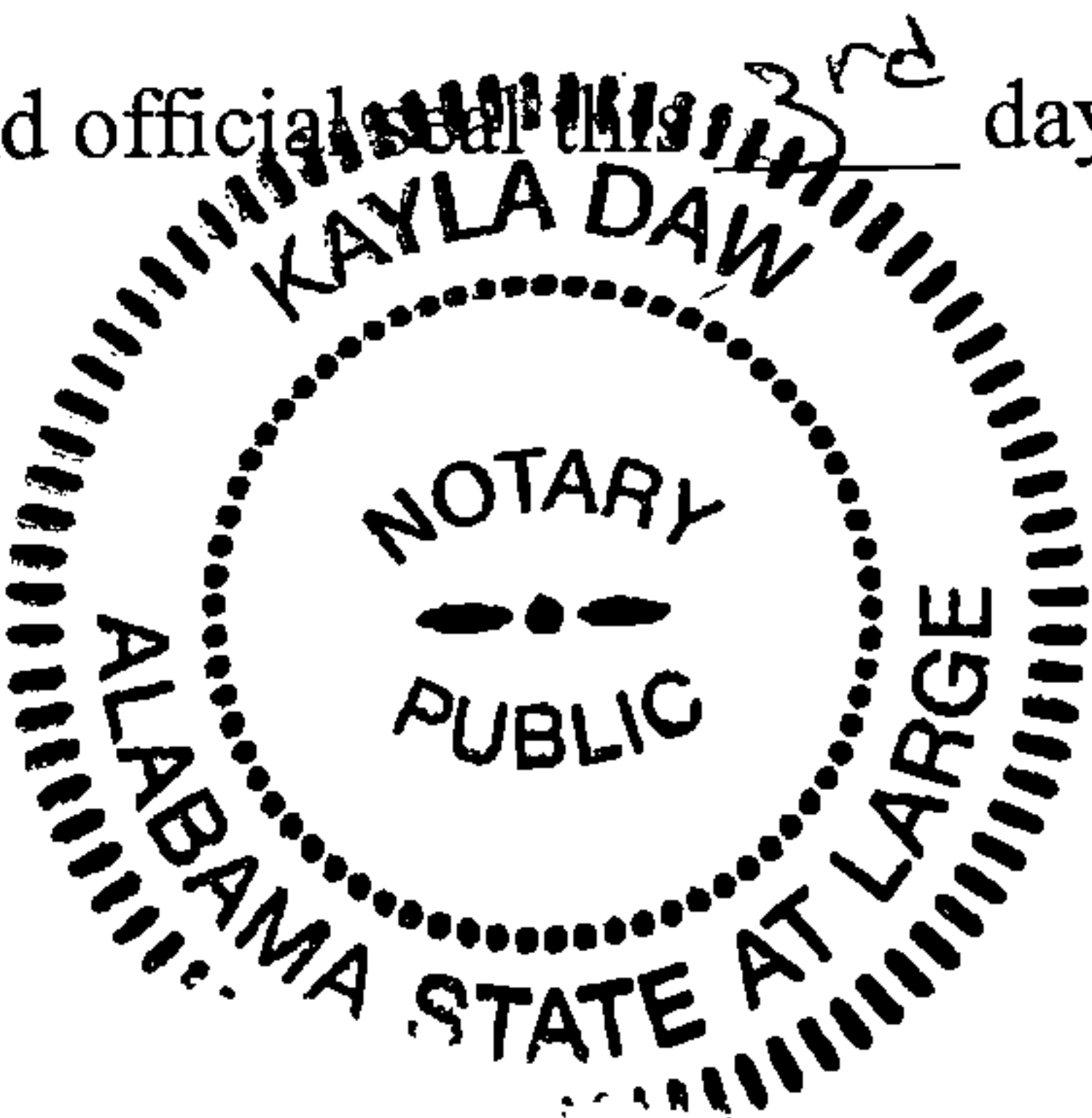
