KNOW ALL MEN BY THESE PRESENTS: That, for and in consideration of TWO HUNDRED FIFTY-FIVE THOUSAND AND NO/100 DOLLARS (\$255,000.00) and other good and valuable consideration, this day in hand paid to the undersigned Grantors, **ZACHARY MAZIARZ and BAYLEY MAZIARZ, husband and wife** (hereinafter referred to as Grantors), the receipt whereof is hereby acknowledged, the Grantors do hereby give, grant, bargain, sell and convey unto the Grantees, **COLBY BRENT PATE and LEXI SKYE BARNETTE** (hereinafter referred to as Grantees), for and during their joint lives and upon the death of either, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, their heirs and assigns, the following described Real Estate, lying and being in the County of Shelby, State of Alabama, to-wit:

Lot 30, according to the Survey of Park Place Third Addition, as recorded in Map Book 17, Page 83, in the Probate Office of Shelby County, Alabama.

Subject to rights-of-way, covenants, restrictions, easements, agreements, setback lines, reservations, mineral/mining rights, and declarations of record, if any.

\$250,381.00 of the above-recited consideration is being paid with proceeds from a purchase money mortgage being recorded simultaneously herewith.




