STATUTORY WARRANTY DEED - Jointly for Life with Remainder to Survivor

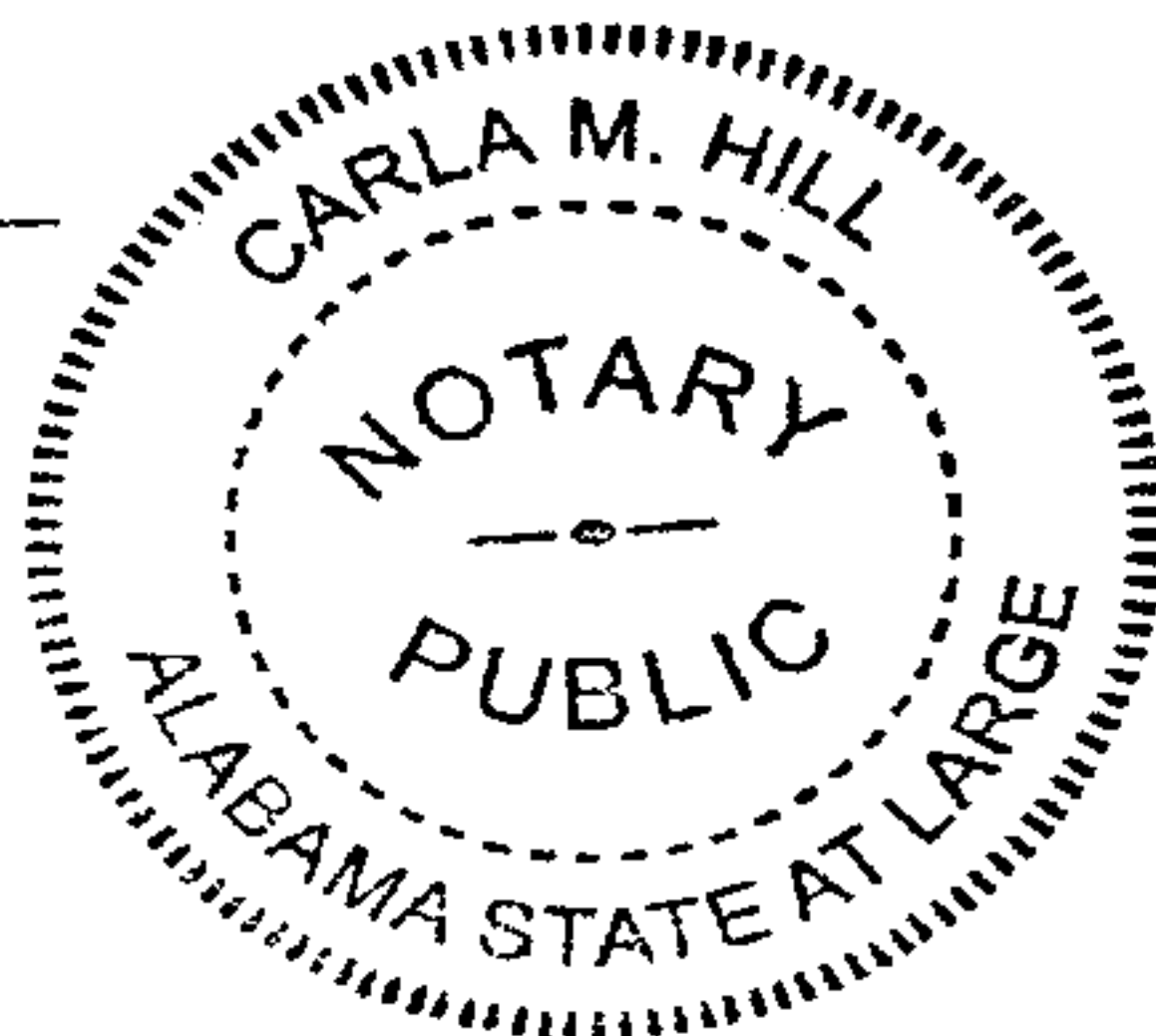
