Franks, an unmarried person**, whose address is 475 Talon Court, Birmingham, AL 35242, (hereinafter "Grantor", whether one or more), by **Jerry Reaves Stroupe, III and Lenora N. Stroupe**, whose address is 3025 Cross Grove Lane, Birmingham, AL 35242, (hereinafter "Grantee", whether one or more), the receipt and sufficiency of which are hereby acknowledged, Grantor does, by these presents, grant, bargain, sell, and convey unto Grantee **Jerry Reaves Stroupe, III and Lenora N. Stroupe, as joint tenants with right of survivorship**, the following described real estate situated in Shelby County, Alabama, **the address of which is 3025 Cross Grove Lane, Birmingham, AL 35242 to-wit:**


