

- 6. Type of Trust. Revocable. SUE ELLEN HALL ESLECK and FREDERICK LEE ESLECK retain the right to revoke the Trust during their lifetimes.
- 7. <u>Co-Trustees' Authority</u>. There must be majority agreement for the co-Trustees to exercise the Trustees' powers. The co-Trustees have the authority to sign or otherwise authenticate under the Trust.
- 8. <u>Taxpayer Identification Number</u>. The taxpayer identification number is available upon appropriate request by interested party.
- 9. <u>Title to Trust Assets</u>. Title to trust property shall be held in the following name: "SUE ELLEN HALL ESLECK and FREDERICK LEE ESLECK, as Trustees of the 2023 ESLECK JOINT REVOCABLE TRUST," or in any other name selected by the Trustees.
- 10. <u>Trust not Revoked.</u> The Trust has not been amended, modified, or revoked in any manner which would cause the representations contained in this Certification of Trust to be incorrect.
- 11. Third Party Reliance. Any third party may rely on the stated authority of the Trustees. Alabama Code §19-3B-1012.
- 12. <u>Certification</u>. The undersigned certify that the statements in this Certification of Trust are true and correct.


