9. Title to Trust Assets. Title to trust property shall be held in the following name: "SUE ELLEN HALL ESLECK and FREDERICK LEE ESLECK, as Trustees of the 2023 ESLECK JOINT REVOCABLE TRUST," or in any other name selected by the Trustees.
10. Trust not Revoked. The Trust has not been amended, modified, or revoked in any manner which would cause the representations contained in this Certification of Trust to be incorrect.
11. Third Party Reliance. Any third party may rely on the stated authority of the Trustees. *Alabama Code §19-3B-1012.*

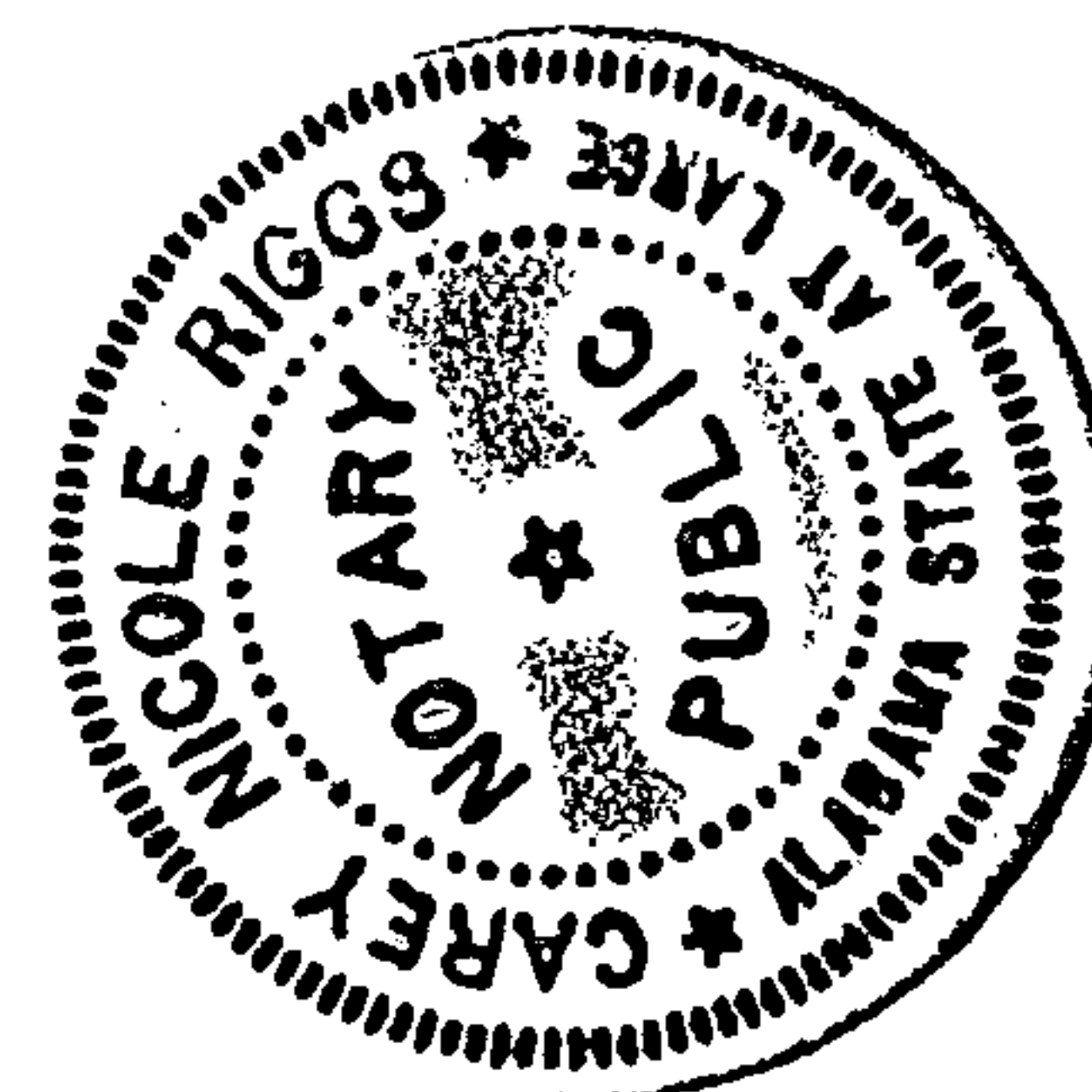
