The property conveyed does not constitute the homestead of the grantor nor that of his spouse.

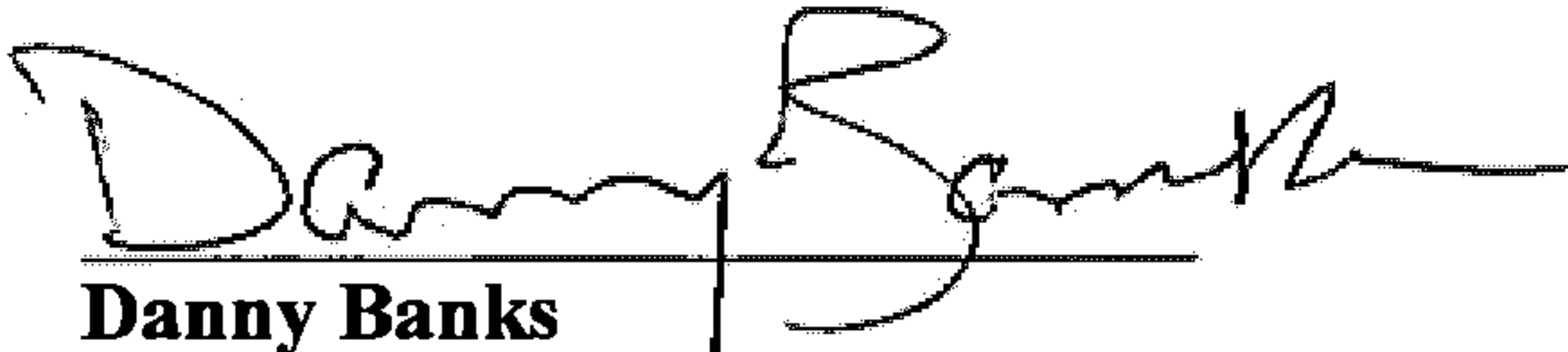

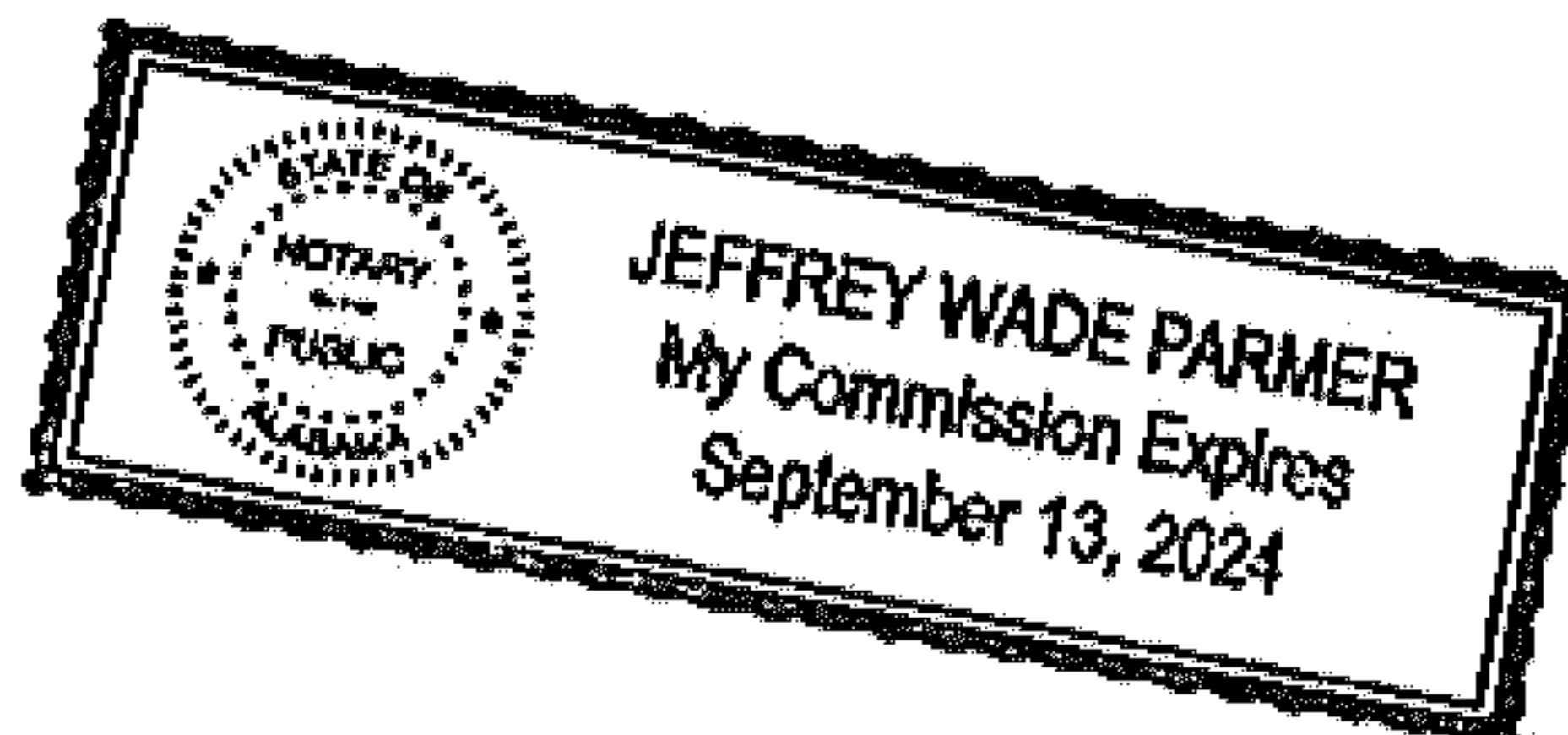
