WHEREAS that certain Declaration of Covenants, Conditions and Restrictions for Blackridge Residential Association, Inc. 



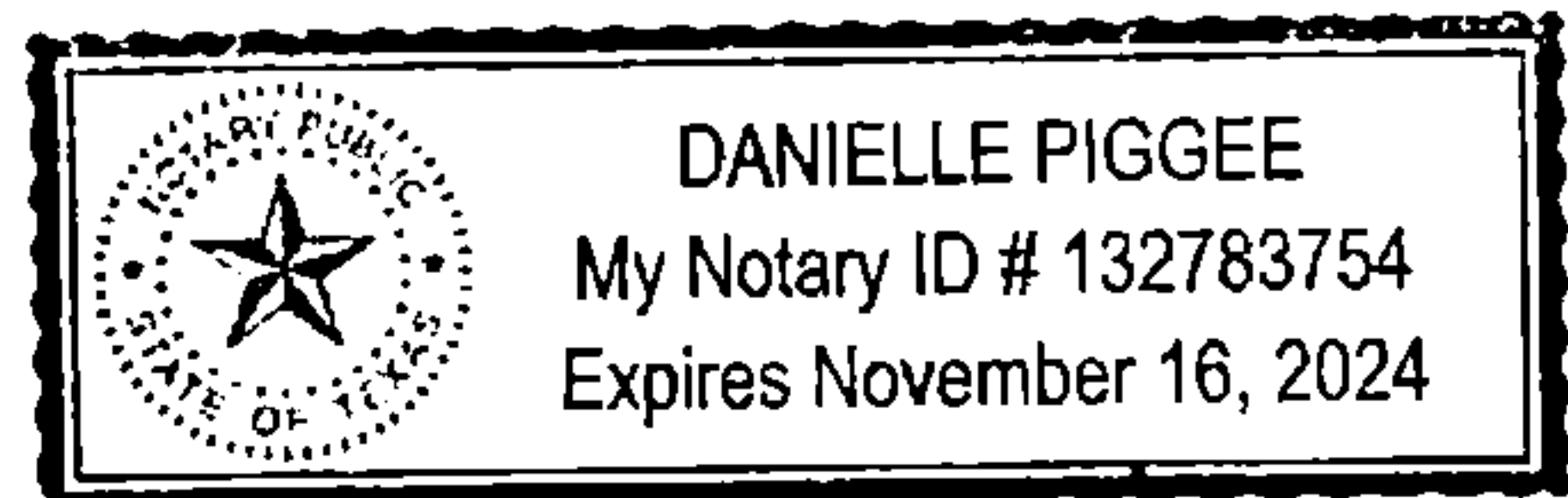
