



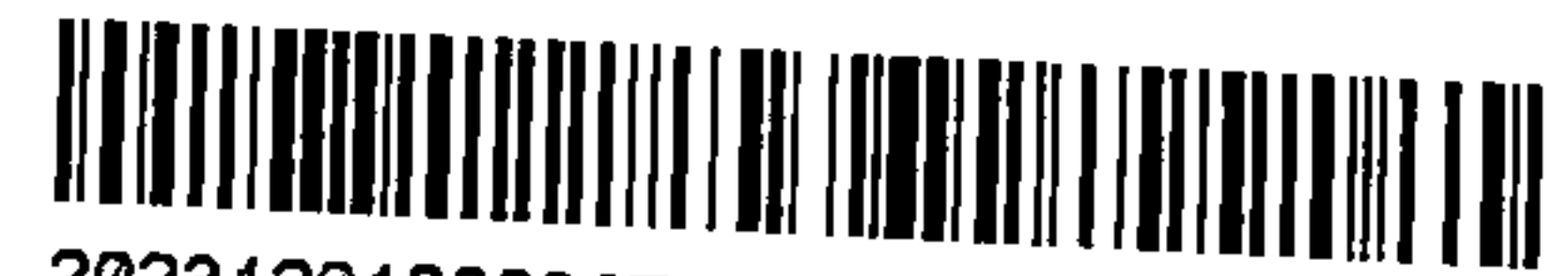

1. There is a valid and existing trust, having been created by **THE RONNIE & JO ANN STONE REVOCABLE LIVING TRUST** under agreement dated August 23, 2023. A Certificate of Trust was recorded in Instrument No. 20230829000260870, in the Probate Office of Shelby County, Alabama.

  - A. The original settlor(s) and successor settlor(s), if any, of the trust was/were:

  - B. The following person(s) contributed money, funds, real property, or personal property to the trust:  
**RONNIE DREW STONE and JO ANN STONE**
  - C. The original settlor(s), **RONNIE DREW STONE and JO ANN STONE** are alive and well.
  - D. The original trustees **RONNIE DREW STONE and JO ANN STONE** are alive and well
  - E. The name and address of the currently acting trustees:

  - G. The tax identification number of the trust is intentionally omitted for privacy reasons.





3. Unless otherwise delineated, the administrative and/or managerial powers of the trustees shall be governed by the trustees' powers provisions of the laws of the State of Alabama, and the trustees shall be specifically allowed to buy, sell, rent, lease, or otherwise dispose of all trust property, both real and personal.
4. Trust Property should be titled as follows: **RONNIE DREW STONE and JO ANN STONE, Trustees of THE RONNIE and JO ANN STONE REVOCABLE LIVING TRUST dated August 23, 2023** or in the alternative, **THE RONNIE & JO ANN STONE REVOCABLE LIVING TRUST**
5. The **RONNIE & JO ANN STONE REVOCABLE LIVING TRUST dated August 23, 2023**, is one and the same as the RONNIE & JO ANN STONE Revocable Trust dated August 23, 2023, under Certificate of Trust recorded in Instrument No. 20230829000260870, in the Probate Office of Shelby County, Alabama.
6. An alternate description will be effective to title assets in the name of the trust or to designate the trust as a beneficiary if the description includes the name of at least one initial or successor Trustee, any reference indicating that property is being held in a fiduciary capacity, and the date of the trust.
7. The named successor trustees are: RONDA LOCKE, unless she predeceases RONNIE DREW STONE & JO ANN STONE. IF RONDA LOCKE predeceases RONNIE DREW STONE & JO ANN STONE, the successor trustee shall be AMBER RAGSDALE.
8. [Applicable if there are multiple trustees].
  - A. The following trustees have the authority to sign documents.
  - B. Only one trustee shall be necessary to sign documents on behalf of trust.
9. [Applicable if there are named successor trustees]
  - A. Upon the death of either of the primary trustees, the remaining primary trustee shall succeed as sole trustee.
  - B. Upon the death of the remaining primary trustee, the previously named successor trustees shall succeed as specified.
10. Our Trust is Revocable. The persons having the power to revoke are the Trustees. To the best of the undersigned's knowledge the trust has not been revoked, modified, or amended in any manner that would cause the representations and statements contained herein to be incorrect.



11. No person or entity paying money to or delivering property to my Trustee shall be required to see its application. All persons relying on this document regarding the Trustee and his powers over trust property shall be held harmless for any resulting loss or liability from such reliance.
12. A Copy of this Certificate of Trust shall be just as valid as the original.

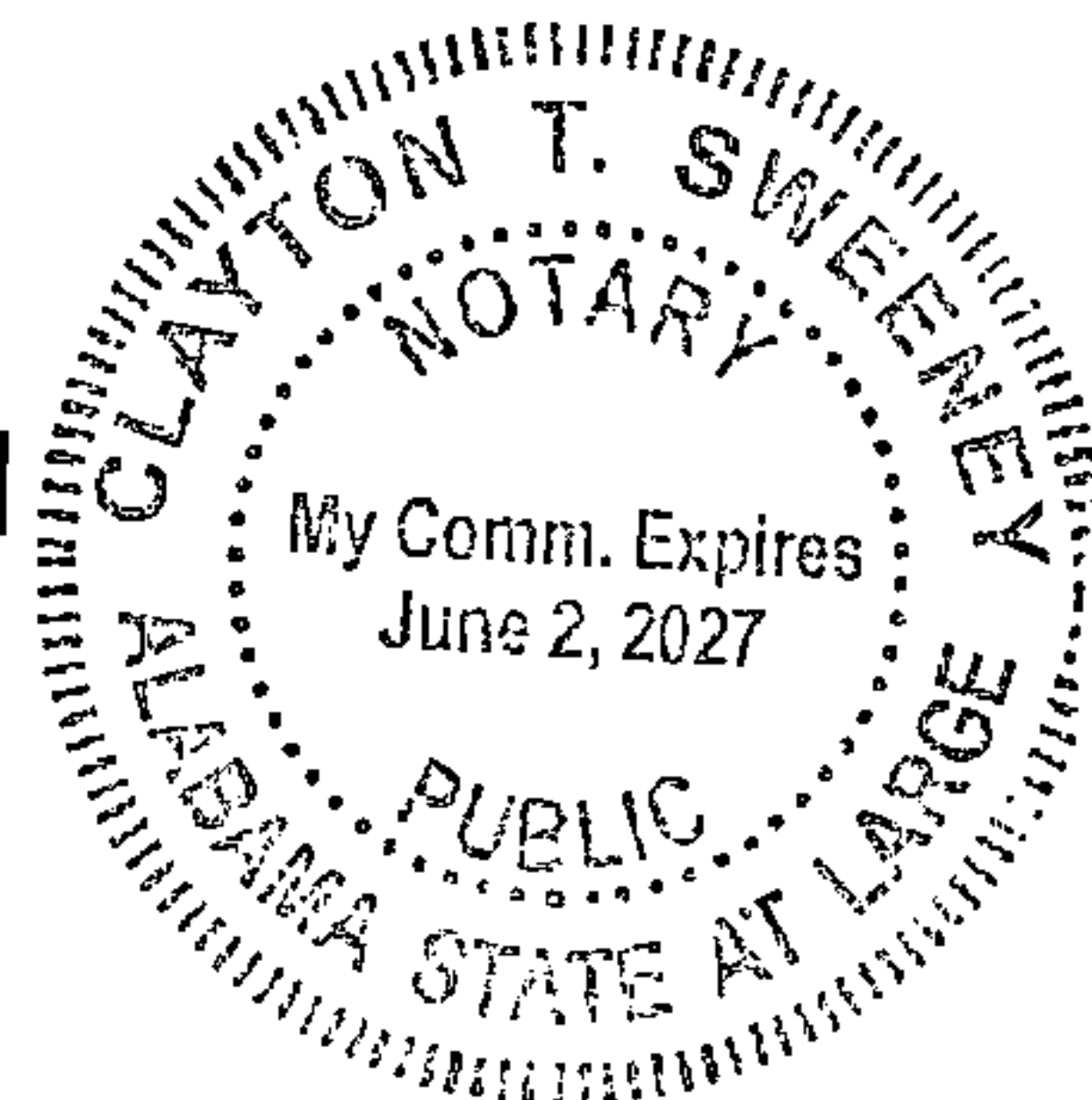


