SECOND AMENDMENT TO DECLARATION OF RESTRICTIONS, COVENANTS AND CONDITIONS AND GRANT OF EASEMENTS (WHITE STONE SHOPPING CENTER)

THIS SECOND AMENDMENT TO DECLARATION OF RESTRICTIONS, COVENANTS AND CONDITIONS AND GRANT OF EASEMENTS ("Amendment") is made and entered into as of the 3/51 day of 2023, by and between PSM ALABAMA HOLDINGS, LLC, an Alabama limited liability company ("Publix"), and MAVIS SOUTHEAST LLC, a Delaware limited liability company ("Mavis"), with reference to the following facts:

WHEREAS, that certain Declaration of Restrictions, Covenants and Conditions and Grant of Easements ("White Stone Shopping Center") was made and executed by Alabaster Retail Property, LLC and Schilleci White Stone, LLC, as the then Owner of the Shopping Center Tract and the Outparcels, and now owned by Publix, said Declaration being recorded as Instrument No. 20031124000768400, as amended by that certain Amendment to Declaration of Restrictions, Covenants and Conditions and Grant of Easements, dated May 4, 2006, recorded as Instrument No. 20060525000248710, both in the Office of the Judge of Probate of Shelby County, Alabama (collectively, the "Declaration"), with capitalized terms not otherwise defined in this Amendment having the same meaning ascribed to such terms in the Declaration; and

WHEREAS, the parties desire to amend the Declaration to permit additional parking on Outparcel 5;

NOW, THEREFORE, for and in consideration of the sum of ONE AND NO/100 DOLLAR (\$1.00) and other valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Owners do hereby amend the Declaration and agree as follows:

1. Parking Area – Outparcel 5. Section 3.2 of the Declaration, entitled "Parking Areas," is hereby amended to include the following paragraph:

Notwithstanding anything contained in this Section 3.2 to the contrary, Outparcel 5 shall contain at least twenty-nine (29) parking spaces and shall not need to adhere to any other parking ratio, except those required by any governmental agency having jurisdiction.

2. <u>Insurance – Self-Insure</u>. Section 10.1 of the Declaration, entitled "Liability Insurance," is hereby amended to include the following paragraph:

Notwithstanding anything contained in this Section 10.1 to the contrary, the obligation to carry insurance pursuant to this Declaration shall be suspended to an Owner for as long as the aggregate net worth of an Owner and its affiliated business organizations (as determined in accordance with generally accepted accounting principles) is at least \$250,000,000.00, as evidenced by financial statements of such Owner and its affiliated business organizations that are publicly filed with the Securities and Exchange Commission (or similar regulatory entity with public records access). Each Owner agrees to furnish to any other Owner requesting evidence of such net worth evidence to certify that such Owner is in compliance with this Section.

- 3. <u>Definitions</u>; <u>Effect on Declaration</u>. All capitalized terms in this Amendment, unless otherwise defined or modified herein, shall have the same meaning as set forth in the Declaration. Except as modified herein, the Declaration remains unchanged. In the event of a conflict between the Declaration and this Amendment, this Amendment shall control and govern.
- 4. <u>Declaration Ratified</u>. The terms and provisions of the Declaration, as modified by this Amendment, are hereby ratified and affirmed by the parties hereto.
- 5. <u>Counterparts</u>. This Amendment may be executed in one or more counterparts, each of which shall be deemed an original, but all shall constitute one and the same Amendment; provided, however, this Amendment shall not be effective until fully executed by both parties.
