WARRANTY DEED, JOINT TENANTS WITH RIGHT OF SURVIVORSHIP

KNOW ALL MEN BY THESE PRESENTS

That in consideration of One Million Seven Hundred Fifty Thousand and 00/100 Dollars (\$1,750,000.00) to the undersigned grantor in hand paid by the grantees herein, the receipt whereof is acknowledged, I,

Jody C. Jones, an unmarried person

(hereinafter referred to as "Grantor") do grant, bargain, sell and convey unto

Louis A. Baverso and Susan Carole Harlan

(hereinafter referred to as "Grantees") as joint tenants with right of survivorship, the following described real estate situated in Shelby County, Alabama to-wit:

PARCEL I:

Lot 67-A, according to the Resurvey of Lots 65, 66 and 67 of South Lake, First Addition, as recorded in Map Book 25, page 145, in the Probate Office of Shelby County, Alabama.

PARCEL II:

Lot 68, according to the Survey of Southlake First Addition, as recorded in Map Book 14, page 31, in the Probate Office of Shelby County, Alabama.

And I do for myself and for my heirs, executors, and administrators covenant with Grantees, their heirs and assigns, that I am lawfully seized in fee simple of said premises; that they are free from all encumbrances, unless otherwise noted above; that I have a good right to sell and convey the same as aforesaid; that I will and my heirs, executors and administrators shall warrant and defend the same to Grantees, their heirs and assigns forever, against the lawful claims of all persons.

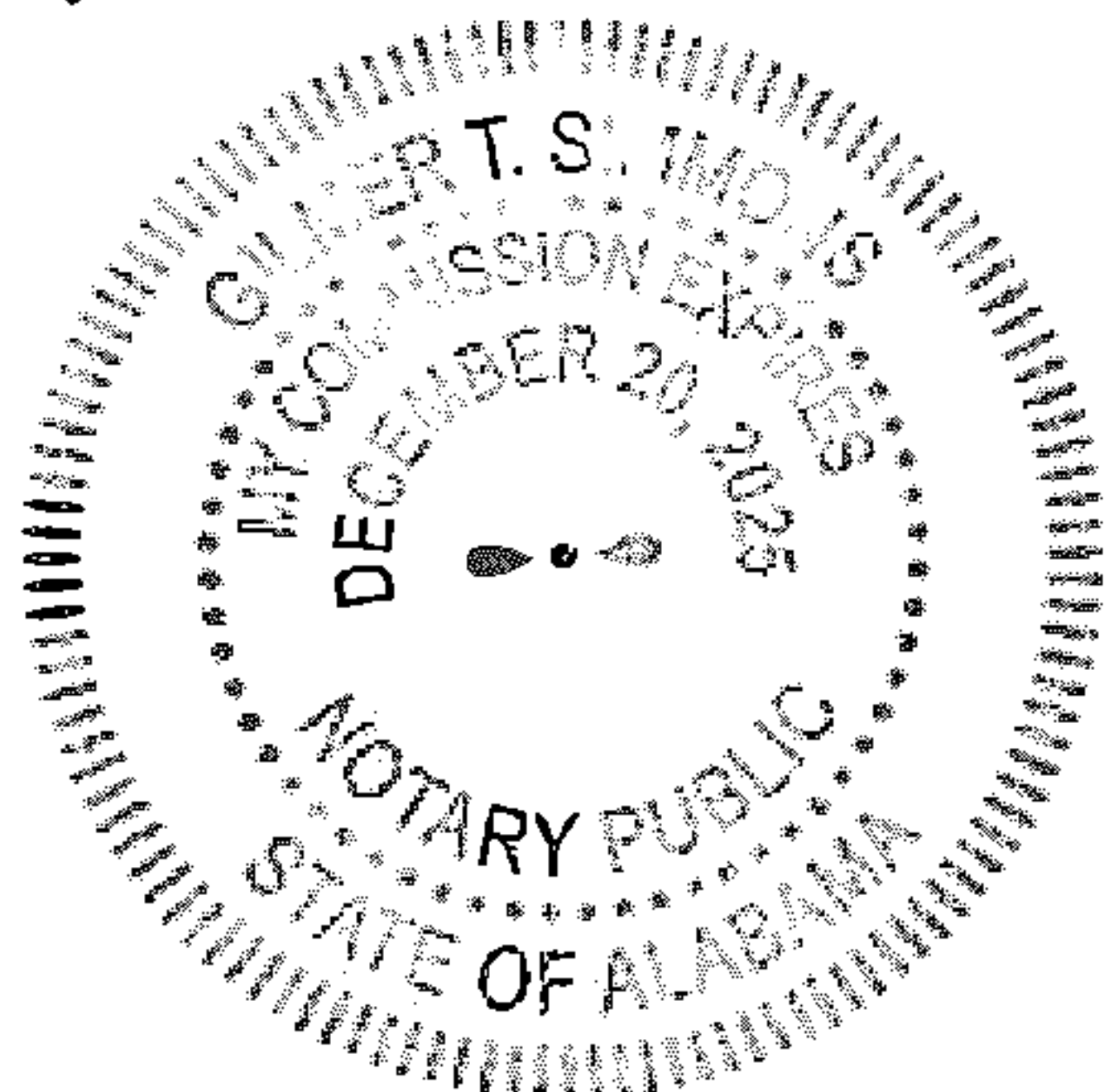
