Know All Men by These Presents: That in consideration of **One Hundred Eighteen Thousand and 00/100 Dollars (\$118,000.00)**, to the undersigned Grantor, in hand paid by the Grantees herein, the receipt where is acknowledged, **CARLISLE CREEK CONSTRUCTION, LLC** (herein referred to as Grantor), grant, bargain, sell and convey unto **STEVEN LEE and REBECCA LEE** (herein referred to as Grantees), the following described real estate, situated in **SHELBY** County, Alabama, to-wit:

Lot 4, according to the Revised Final Plat of White Oak Manor Subdivision, as recorded in Map Book 47, Page 47, in the Probate Office of Shelby County, Alabama.

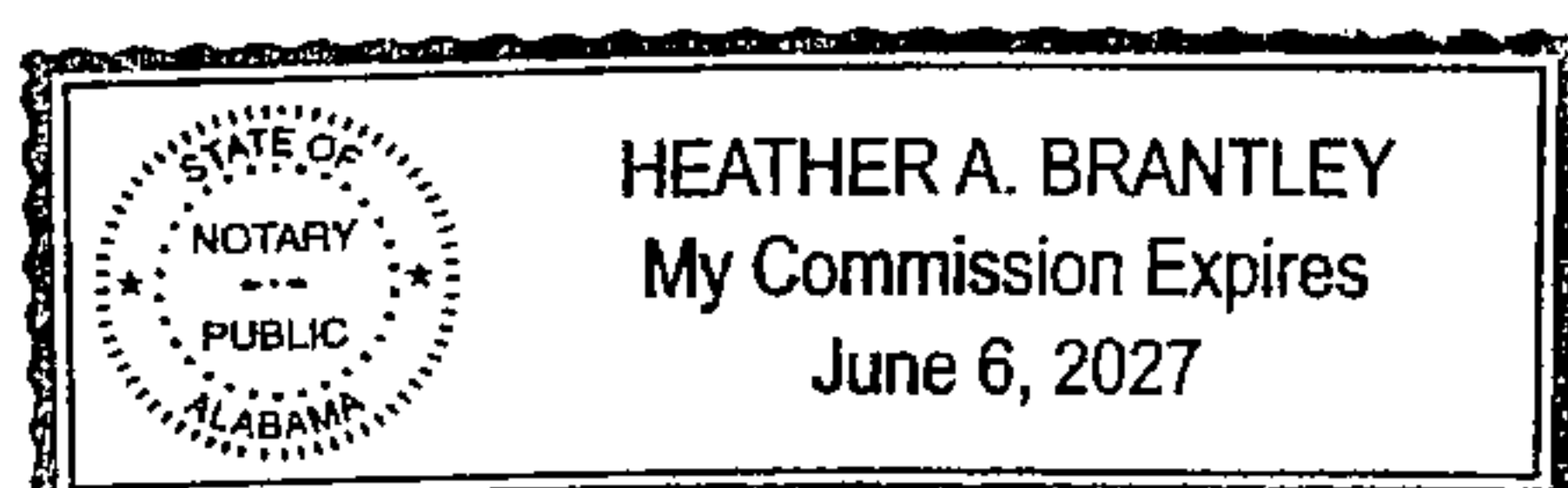

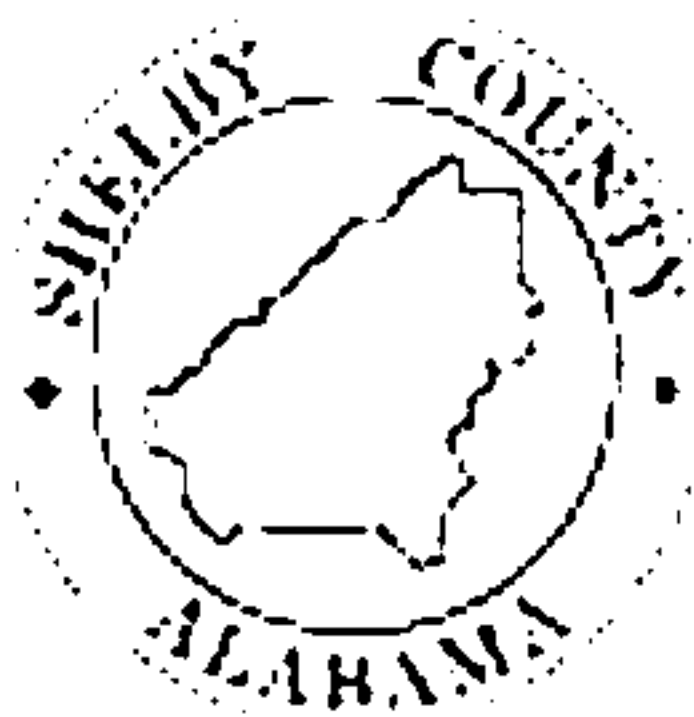
