WARRANTY DEED WITH JOINT RIGHT OF SURVIVORSHIP

That for and in consideration of **TWO HUNDRED NINETY THOUSAND AND NO/100 (\$290,000.00) DOLLARS**, and other good and valuable consideration, this day in hand paid to the undersigned **BENJAMIN L. HAYES and ERIN G. HAYES**, husband and wife, (herein referred to as "Grantors"), in hand paid by the Grantees herein, the receipt whereof is hereby acknowledged, the Grantors do hereby give, grant, bargain, sell and convey unto the Grantees, **HEATHER L. STENNIES and PAUL STENNIES**, (herein referred to as "Grantees"), for and during their joint lives and upon the death of either, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, all of the Grantors' interest in the following-described Real Estate situated in, **SHELBY COUNTY, ALABAMA**, to wit:

Lot 7, according to the Survey of Country Hills Subdivision, Phase One, as recorded in Map Book 11, Page 41, in the Probate Office of Shelby County, Alabama, being situated in Shelby County, Alabama.

Subject to:

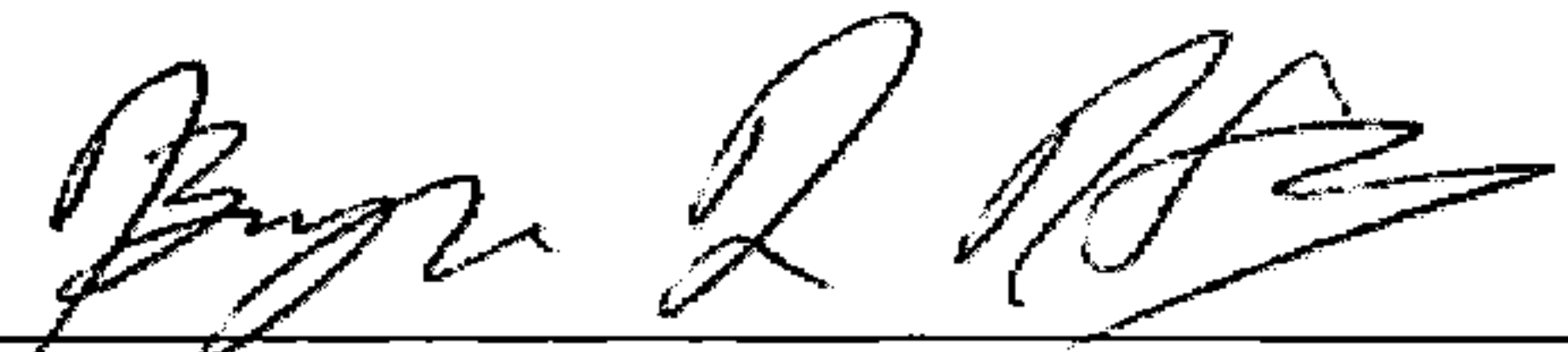
The purchase of the herein described real property is being financed in whole or in part by the proceeds of a purchase money mortgage being executed simultaneously herewith.

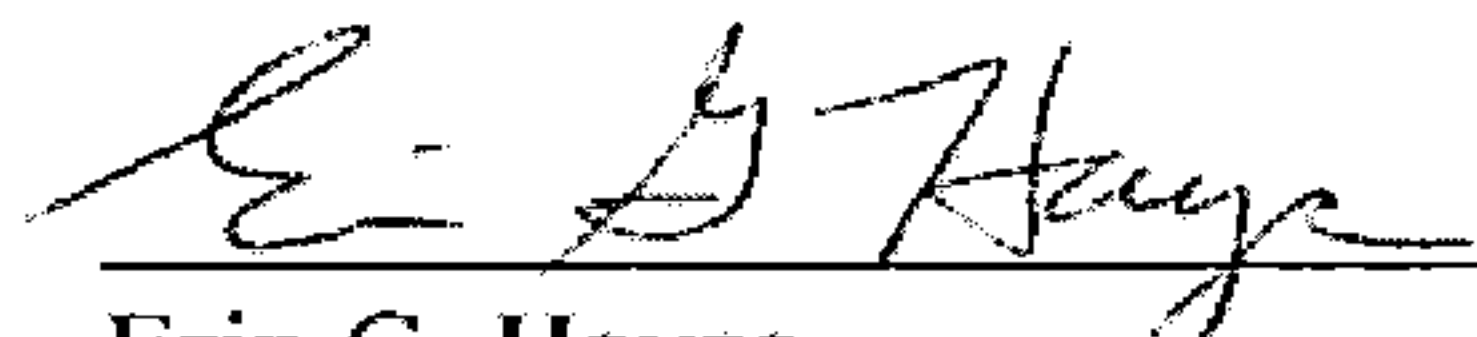

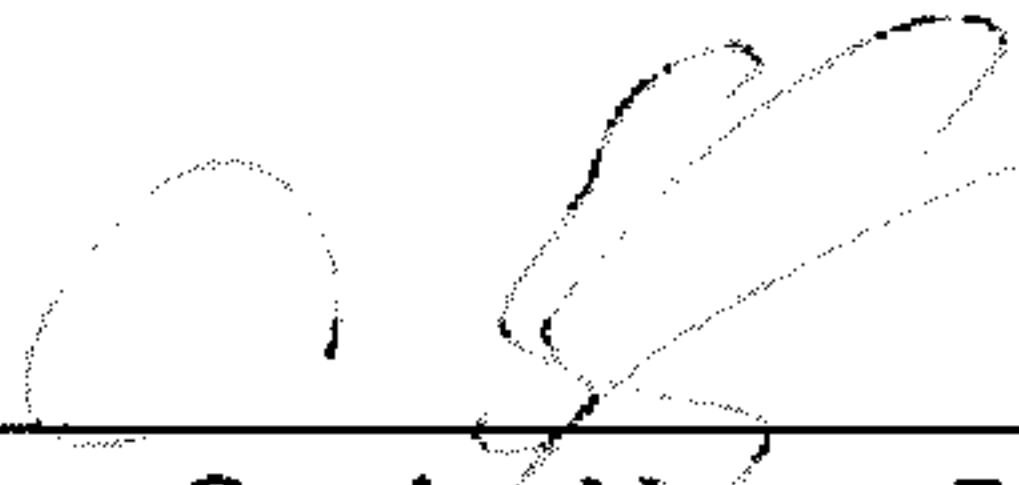
