Powers and Stephanie Powers a married couple (hereinafter grantor, whether one or more), do grant, bargain, sell and convey unto William Marlon Beavers and Patti Walton Beavers (hereinafter Grantees), as joint tenants with rights of survivorship, all of my/our right, title and interest in the following described real estate, situated in Shelby County, Alabama.




