CORPORATION WARRANTY DEED

KNOW ALL MEN BY THESE PRESENTS,, That in consideration of FOUR HUNDRED THIRTY EIGHT THOUSAND TWO HUNDRED FORTY THREE AND 00/100 D O L L A R S (\$438,243.00) and other good and valuable consideration the receipt and sufficiency whereof is hereby acknowledged, Clayton Properties Group, Inc., a TN corporation (herein referred to as GRANTOR) does by these presents grant, bargain, sell and convey unto Bailey Orr, a single woman (herein referred to as GRANTEE, whether one or more) the following described real estate situated in SHELBY COUNTY, Alabama to-wit:

Lot 255, of the Survey of Simms Landing, Phase 2B, as recorded in Map Book 57, Page 100, in the Office of the Judge of Probate of Shelby County, Alabama.


Note: \$416,330.00 of the purchase price is being paid by the proceeds of a first mortgage loan executed and recorded simultaneously herewith.

TO HAVE AND TO HOLD, to the said GRANTEE, her heirs and assigns forever.

And said GRANTOR does for itself, its successors and assigns, covenant with said GRANTEE, her heirs and assigns, that it is lawfully seized in fee simple of said premises, that they are free from all encumbrances, that it has a good right to sell and convey the same as aforesaid, and that it will, and its successors and assigns shall, warrant and defend the same to the said GRANTEE, her heirs, executors and assigns forever, against the lawful claims of all persons.

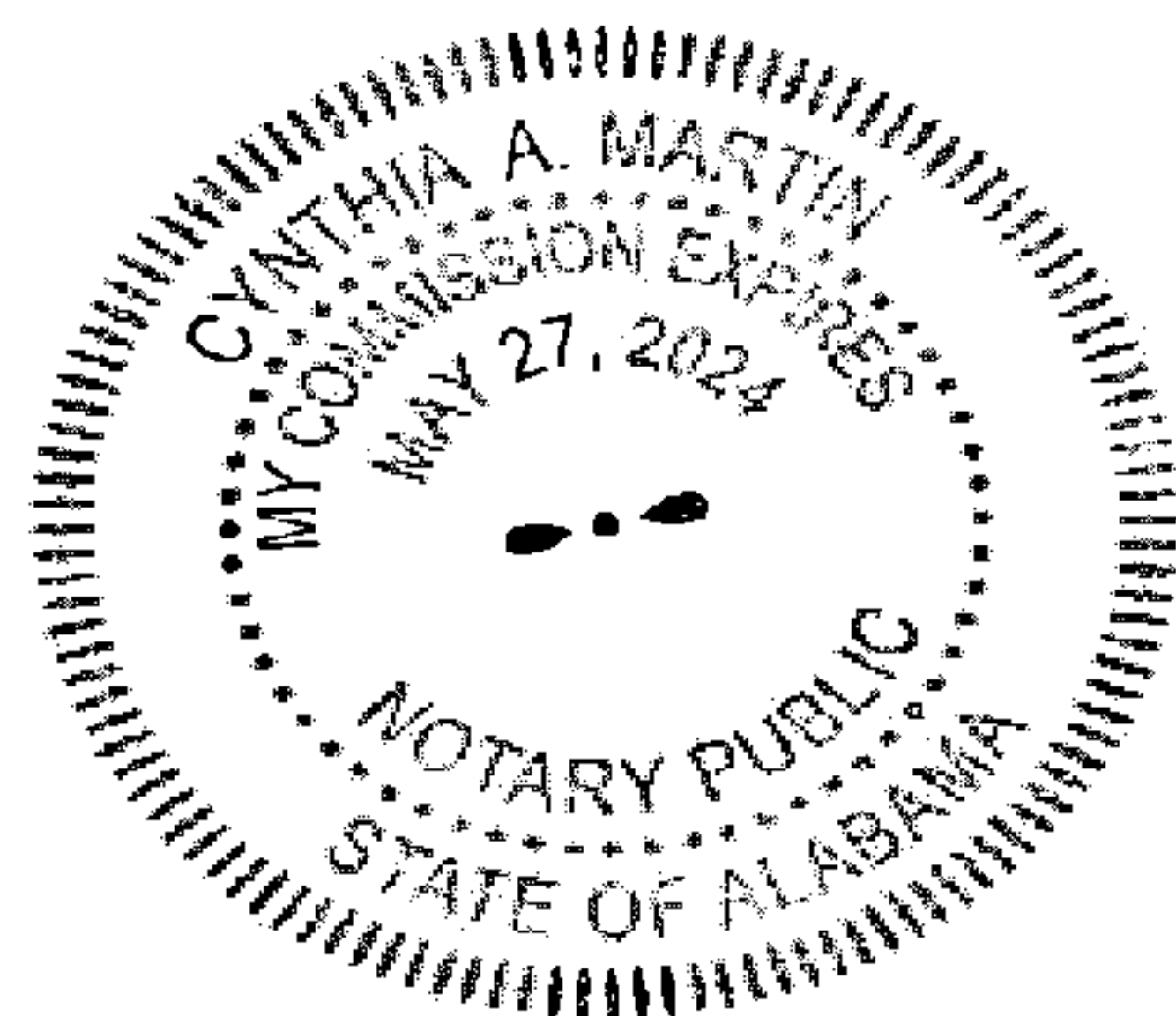



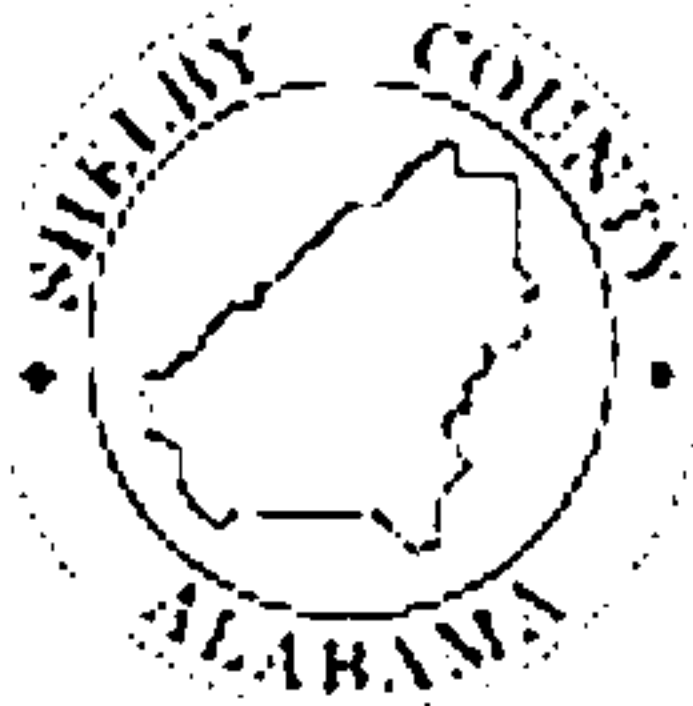
