WARRANTY DEED, JOINT TENANTS WITH RIGHT OF SURVIVORSHIP

SHELBY COUNTY KNOW ALL MEN BY THESE PRESENTS

That in consideration of **ONE HUNDRED SIXTY FIVE THOUSAND AND 00/100 Dollars (\$165,000.00)** to the undersigned grantors in hand paid by the grantees herein, the receipt and sufficiency of which is acknowledged, we,

Robert Stephen Briggs and Lynn Bryan Briggs, husband and wife (Grantors as to Parcel I)
And Lacey Briggs Middleton, a married woman (Grantor as to Parcel II)

(hereinafter referred to as “Grantors”) do grant, bargain, sell and convey unto

Robert Farley and Debra Farley

(hereinafter referred to as “Grantees”), as joint tenants with right of survivorship, the following described real estate situated in Shelby County, Alabama to-wit:

Parcel I: Lot 4, according to the Survey of McFadden Oaks, as recorded in Map Book 21, Page 132, in the Probate Office of Shelby County, Alabama.

Parcel II: Lot 1, according to the Final Plat of The Briggs Family Subdivision, as recorded in Map Book 59, Page 16, in the Probate Office of Shelby County, Alabama.

The property described above as parcel II and conveyed herein is not the homestead of Lacey Briggs Middleton or her spouse.

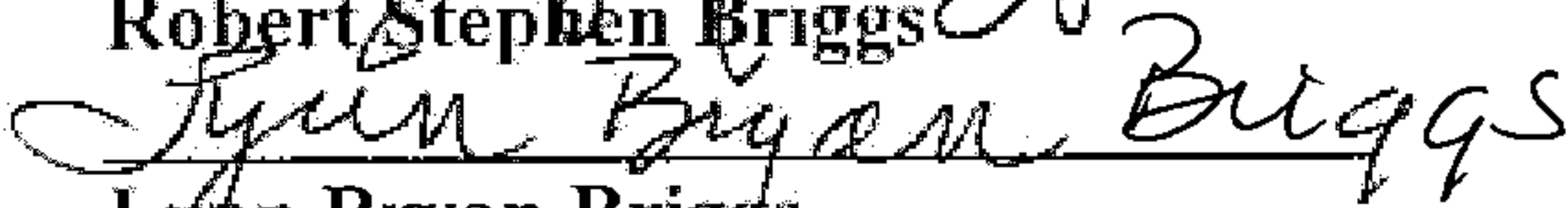
- Subject to:

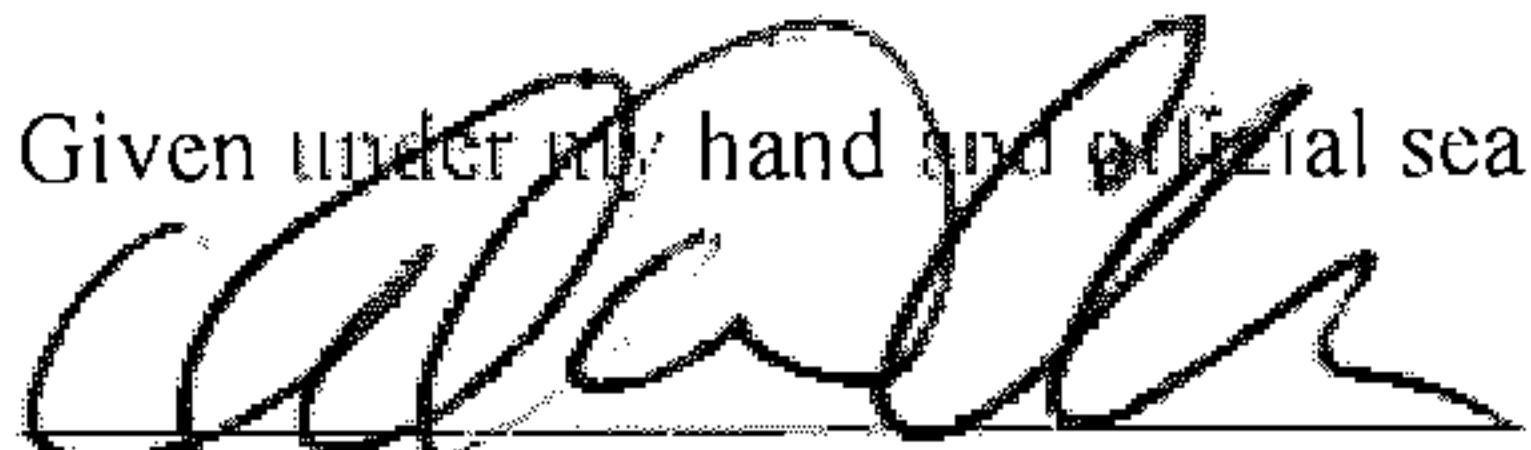

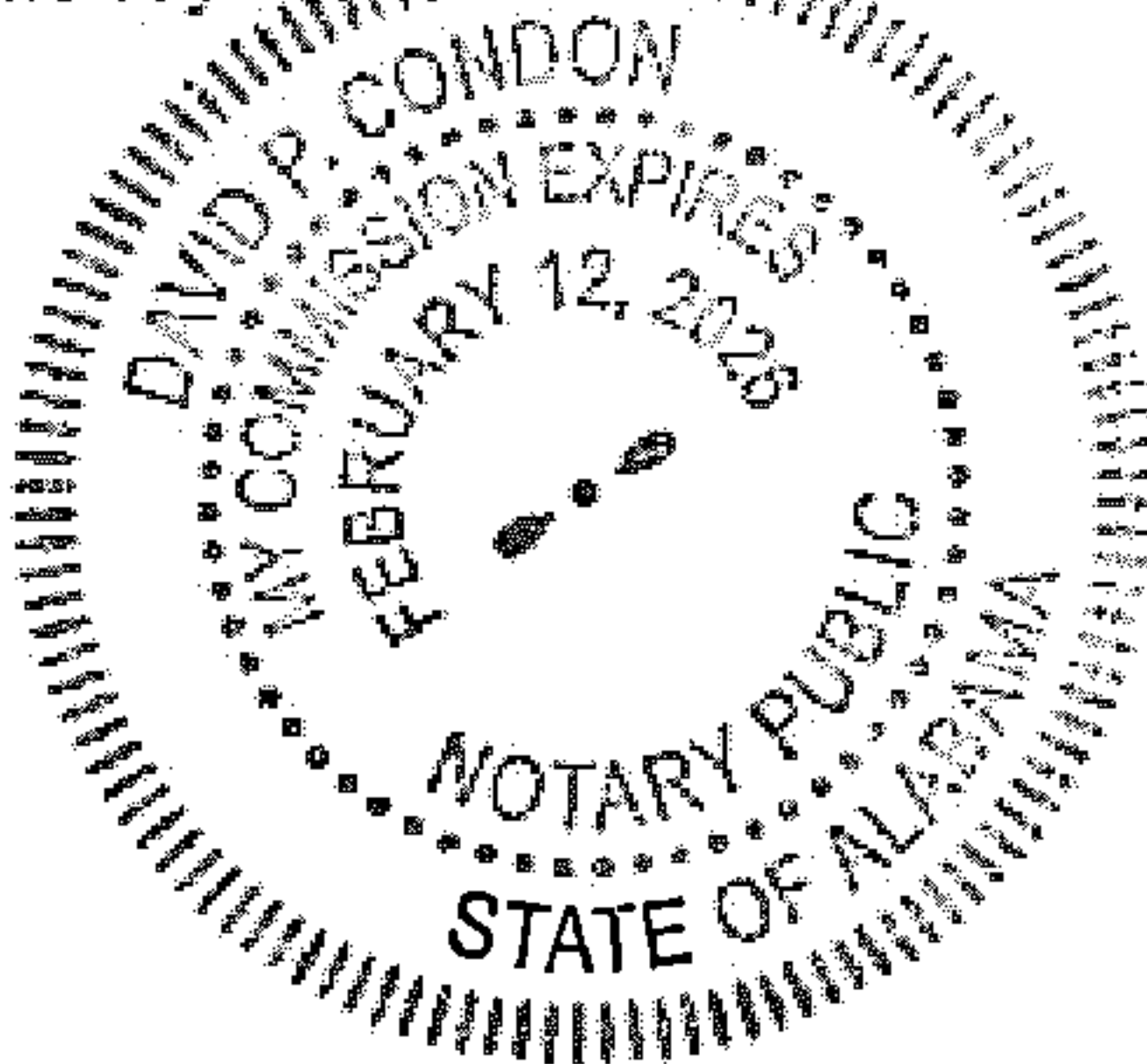

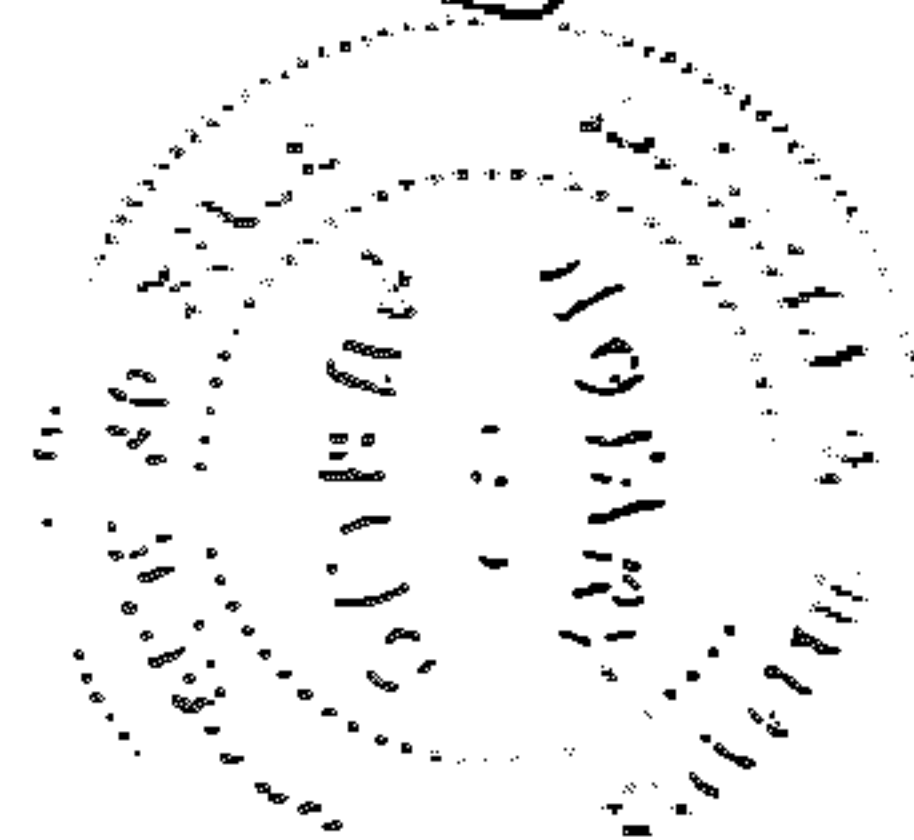
