KNOW ALL MEN BY THESE PRESENTS: That, for and in consideration of TWO HUNDRED FORTY THOUSAND AND NO/100 DOLLARS (\$240,000.00) and other good and valuable consideration, this day in hand paid to the undersigned Grantors, **KIMBERLY TANNER BRIDGEWATER and MONTY BRIDGEWATER, wife and husband** (hereinafter referred to as Grantors), the receipt whereof is hereby acknowledged, the Grantors do hereby give, grant, bargain, sell and convey unto the Grantee, **HALEY BROOKE DAVIS** (hereinafter referred to as Grantee), the following described Real Estate, lying and being in the County of Shelby, State of Alabama, to-wit:



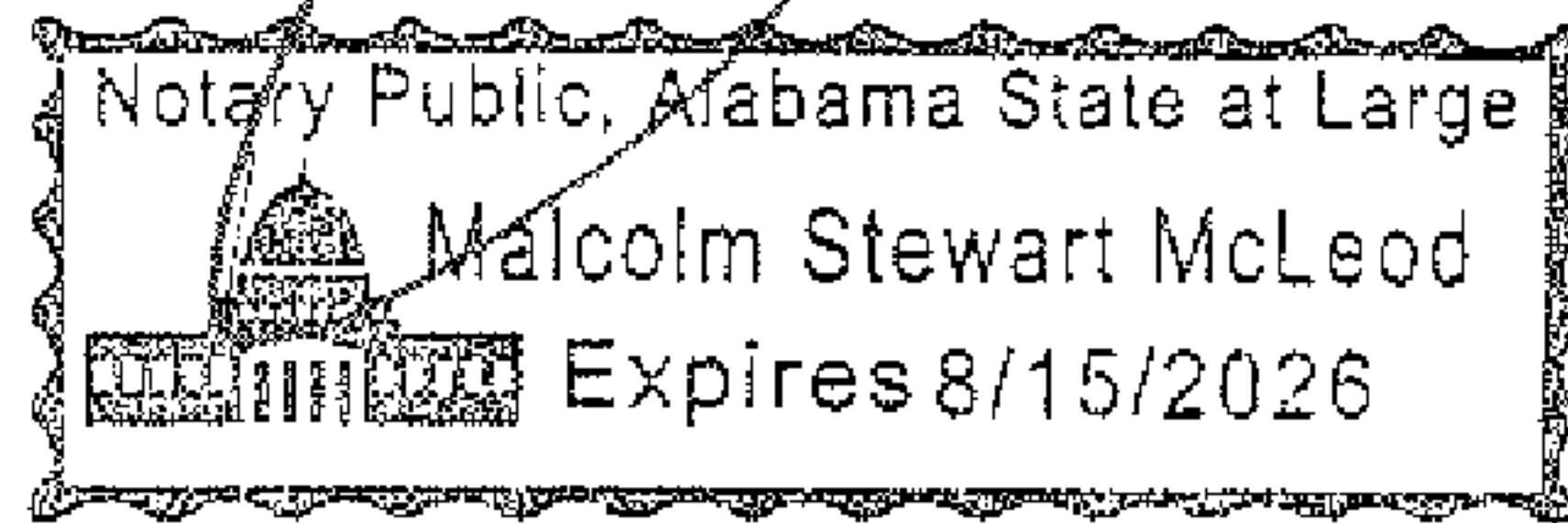
