**On this December 29, 2023, That for and in consideration of TWO HUNDRED SIXTY NINE THOUSAND NINE HUNDRED AND NO/100 (\$269,900.00) DOLLARS, and other good and valuable consideration, this day in hand paid to the undersigned GRANTOR CHAR INVESTMENTS, LLC, an Alabama limited liability company, (herein referred to as "Grantor"), in hand paid by the Grantees herein, the receipt whereof is hereby acknowledged, the Grantor does hereby give, grant, bargain, sell and convey unto the Grantees, JO ANDERSON and WILL OLIVER, (herein referred to as "Grantees"), for and during their joint lives and upon the death of either, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, all of the Grantor's interest in the following-described Real Estate situated in, SHELBY COUNTY, ALABAMA, to wit:**




