
Lot 5, according to the Map of The Estates of Forest Parks, as recorded in Map Book 27, Page 6, in the probate Office of Shelby County, Alabama.

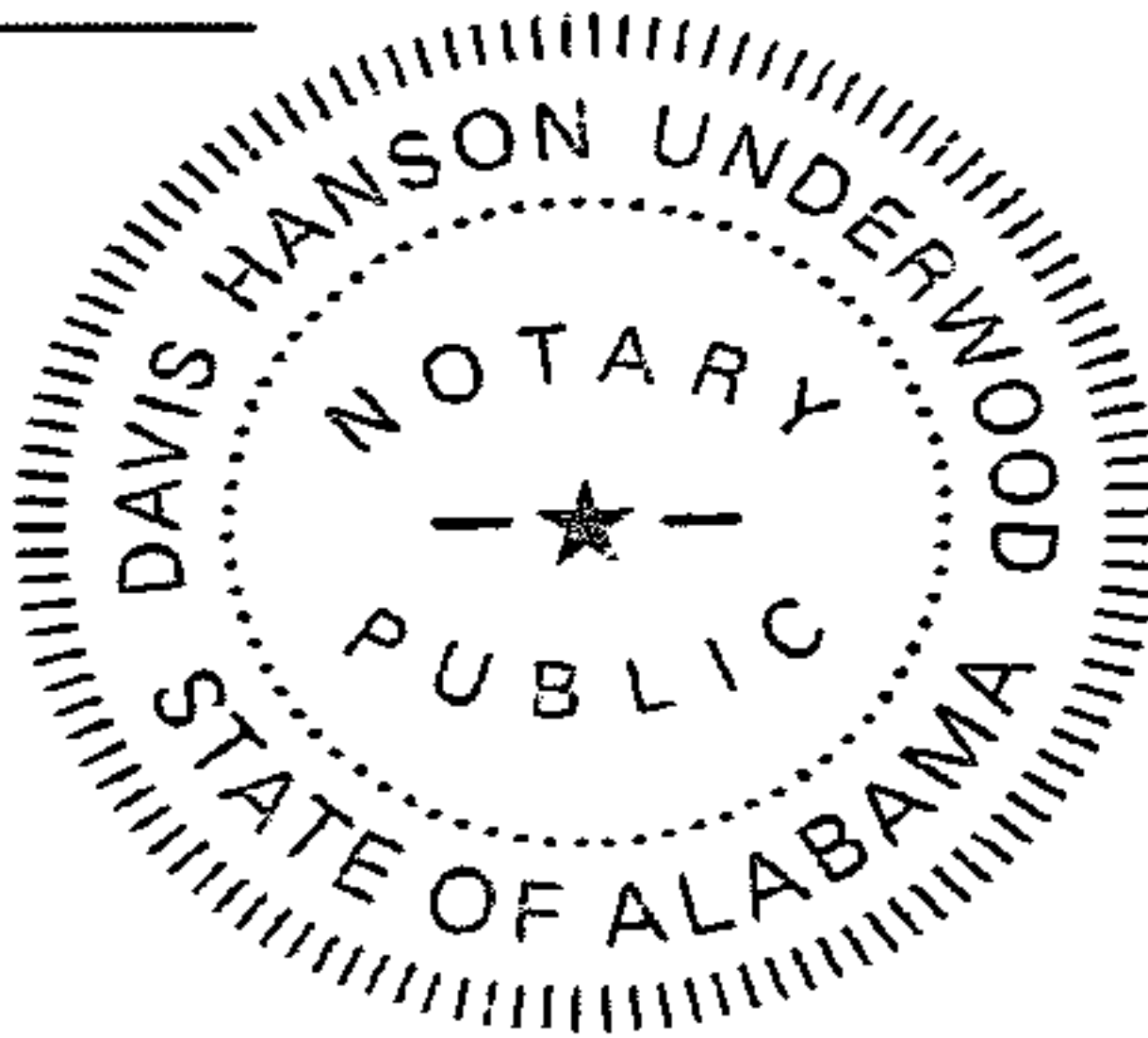
