KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: April 16, 2021, Jeremy Snider and Megan Lee Mackey, ("Mortgagor(s)"), executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc. solely as nominee for Caliber Home Loans, Inc. which said mortgage was recorded April 23, 2021 in Inst. #20210423000202750 in the Office of the Judge of Probate of Shelby County, Alabama; said mortgage having subsequently been transferred and assigned to NewRez LLC d/b/a Shellpoint Mortgage Servicing ("Transferee") by instrument recorded in Inst. 
