KNOW ALL MEN BY THESE PRESENTS: That, for and in consideration FOUR HUNDRED EIGHTY THOUSAND AND 00/100 (\$480,000.00), and other **good** and valuable consideration, this day in hand paid to the undersigned GRANTORS, **DANIEL W. PHIFER and LYNN M. PHIFER, husband and wife**, (hereinafter referred to as GRANTORS), the receipt whereof is hereby acknowledged, the GRANTORS do hereby give, grant, bargain, sell and convey unto the GRANTEES, **MAYURBHAI M. PATEL and DARSHNA J. PATEL**, (hereinafter referred to as GRANTEES), for and during their joint lives and upon the death of either, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, the following described Real Estate, lying and being in the County of Shelby, State of Alabama, to-wit:

Lot 3-A, according to a Resurvey of Lots 1 through 12, Bridgewater Park, as recorded in Map Book 38, Page 43, in the Probate Office of Shelby County, Alabama.


Subject to existing easements, current taxes, restrictions and covenants, set-back lines, rights of way and mortgages, if any, of record.


